

## University of Louisville

### Endowment Match Program 2004-2005 Annual Report - Summary

The following annual report covers programmatic and financial activities supported at the University of Louisville (U of L) by the Council on Postsecondary Education's (CPE) Endowment Match Program (a.k.a. "Bucks for Brains.") For the 2002-04 biennium, the CPE allocated a third round of \$33,333,000 to U of L to be matched dollar-for-dollar by the private sector. During fiscal year 2004-05 U of L submitted and received approval for eleven requests to be funded by state matching funds from Round III. The university secured \$8,037,098 in private funds that were matched by \$8,029,000 in state funds. These funds were used to create four new endowments and expand eleven existing endowments (Table 6). When coupled with existing endowments funded through the Endowment Match program and current requests submitted for approval, these endowments had a combined market value of \$172,987,364 (Table 7) as of June 30, 2005.

#### **Endowment Activity**

The following tables show the effect of activity for the fiscal year ending June 30, 2005 and the cumulative effect of the Endowment Match Program since its inception in July 1998.

As depicted in the Table 1 above, during fiscal year 2004-05 private donations and state matching funds went to support the creation of six (6) new endowed chairs, two (2) new endowed professorships, four (4) new endowed fellowship programs, and two (2) new research mission support funds. As of June 30, 2005 several outstanding candidates were actively being recruited

to fill the endowed chair positions.

Cumulatively, from 1998 through June 30, 2005, a total of sixty-one (61) endowed chairs, seven (7) professorships, fifteen (15) graduate fellowship programs, and twelve (12) mission support projects, have been endowed through the Endowment Match Program at U of L. As of this reporting period, forty-five (45) endowed chair positions and three (3) professorships are occupied or have expenditures. In addition, eight (8) graduate fellowship programs and four (4) mission support projects reported expenditures.

New donor gifts and state matching funds are currently invested and participate in the University of Louisville Foundation’s commingled endowment investment pool and participate in related annual spending policies. The Foundation’s policy requires all endowment funds be invested a full calendar year before the income is disbursed to respective academic units for expenditure.

**Demographic Information**

Table 2 highlights the gender of the faculty and staff incumbents and those supported by the Endowment Match Program. Thirty-eight (38) individuals were hired to fill endowed chair positions. Thirty-one (31) are male and seven (7) are female. Moreover, three (3) individuals were hired for endowed professorships since the inception of the Endowment Match Program. Two (2) are male and one (1) is female. The faculty member and program title for the endowed chair or professorship is provided in Appendix A.

Since 1998 through June 30, 2005, a total of sixty-one (61) new faculty were hired under the auspices of the Endowment Match Program to support research efforts. Forty-two (42) or 69% of those hired were male and nineteen (19) or 31% were female. These faculty positions are assistant or associate professors and are not endowed chairs themselves, but fall under the category of supporting research faculty funded from endowment funds. Of the one-hundred and forty-eight (148) staff positions hired with the Endowment Match funds fifty-nine (59) or 40% are male and eighty-nine (89) or 60% are female.

Table 3 shows the ethnicity of employees hired using Endowment Match Program funds. One hundred fifty-five (155) or 62% of the employees hired since 1998 are White, nine (9) are Black, seventy-seven (77) are Asian, and nine (9) are Hispanic.

A total of thirty-two (32) students received fellowship awards that were funded with endowment proceeds (Table 4). There was an increase in the percentage of minority students supported through the Endowment Match Program this year. Twenty-two (22) of the fellowship recipients (or 72%) were minority students. During fiscal year 2004–05, U of L did not have any scholarships funded from the Endowment Match Program, other than graduate fellowships, displayed as a separate category.

With regard to gender, out of the thirty-two (32) fellowship recipients, nineteen (19) or 59% were male and thirteen (13) or 41% were female.

### **Areas of Concentration:**

#### **Table 5 - Match Program Funds Dedicated to Council Priority Areas for All Matched 2002-04 Appropriation Funds:**

The 2002-04 Endowment Match Program Guidelines stipulate that at least 70 percent of program funds at the research institutions must be used to support Research Challenge programs or new economy disciplines. As of June 30, 2005 U of L received \$10,029,000 of its total \$33,333,000 allocation. That amount was matched with \$10,537,098 in cash gifts and pledges, bringing the total amount of 2002-04 program funds to \$20,566,098. Of that amount \$5,708,019 (28%) will be used to support Research Challenge Programs and \$14,858,079 (72%) will be used to support new economy priority disciplines. The Research Challenge program area supported by this fund is "Molecular Medicine and Biotechnology." All new economy disciplines will receive support from this fund.

### **Sources of Funds, Earnings, and Expenditures:**

#### **Table 6 - Endowments Established or Expanded with State Funds During FY 2004-05:**

Table 6 shows that during the 2004-05 fiscal year, U of L received \$8,029,000 in state matching funds through the Endowment Match Program. The state funds were matched with cash gifts of \$449,205 of which \$58,098 were new endowments and \$391,107 would expand existing endowments. Pledges totaling \$7,587,893 were also recorded. With the addition of new state funds, gifts and pledges, \$16,066,098 will be added to the endowment of the University of Louisville Foundation. These funds were used to create four new endowments and expand eleven existing endowments during the fiscal year. The 2004-05 private sources funding constituted outright cash gifts of \$449,205 (7.5%).

### **Earning and Expenditures:**

As of June 30, 2005, U of L has received \$76,114,307 in state funds and \$69,955,517 in gift funds. Foundation records show an outstanding balance of \$14,766,760 in unpaid pledges on these accounts. The total market value of the 94 endowments established through the Endowment Match Program was \$172,987,364 on June 30, 2005. Over \$4,600,000 was expended for program activities during the fiscal year ending June 30, 2005.

Table 8 is a supplementary report entitled Endowment Match Program, Sponsored Program Funding. It shows FY05 extramural awards totaling \$26,310,064 to those endowed chairs and professors funded from the Endowment Match Program. To date this program has been an overwhelming success. Clearly this influx of research dollars to the Commonwealth responds directly to the call to improve the State's economy and the quality of life for its citizens by

providing high-tech, high-paying jobs. The extramural funding success to date is substantial (\$96.9M) and future growth is certain, as more outstanding researchers fill endowed chair positions. This is an important metric to follow as we measure success into the future.

### **Pledge Payment Schedule**

This report reflects **only** the commitments that are still outstanding. Each outstanding pledge has a payment schedule that fulfills the CPE requirement for fulfillment within a five-year time period. The report shows the individual cash payments received through June 30, 2005 and the anticipated future payments for each of the affected endowment funds. During the 2004-05 fiscal year, \$5,822,208 was paid on outstanding pledges of \$13,900,000. Outstanding pledges of \$8,077,792 remain to be paid over the next several years.

### **Donors**

This report shows the amount of actual funds collected through June 30, 2005, from outright cash gifts, proceeds from estate settlements and cash payments on pledges for endowments created from the Endowment Match Program. To date, the University of Louisville has collected \$73,068,483.
