Early Request for Summer Federal Aid

We've made it easy for you to submit a request to have your federal aid eligibility evaluated. Just log in to ULink and click on "Early Request for Summer Federal Aid" in the Financial Aid section on the Student Services tab. You must have a complete 2016-2017 financial aid file to apply, which includes a 2016-2017 FAFSA and all requested documentation. Be sure to finalize your summer enrollment before you apply. If you submit the online request for summer federal aid before you finalize your summer enrollment, your awards may be delayed and may have to be adjusted. During summer, federal financial assistance is available to eligible applicants who have remaining Pell Grant, TEACH Grant, and/or Direct Subsidized/Unsubsidized Loan eligibility for the award year. Federal Perkins Loan and Work-Study will be awarded to eligible applicants and is dependent upon availability of funding. If awarded financial aid for summer, if you drop a class during the term's 100% tuition credit period, your aid will be reviewed and evaluated for any necessary adjustments. It is strongly recommended if you drop classes with the intention to add others that you drop and add at the same time after the summer census date. Parents of dependent, undergraduate students can also apply for the Parent PLUS Loan, and graduate and law students can apply for the Graduate/Professional PLUS Loan. Award Notifications for 2017-2018

The Student Financial Aid Office will begin creating award packages for continuing and readmitted students by late May/early June. We may contact you for additional information necessary to complete your financial aid file. Regularly check your To Do List for important messages and forms by logging into ULink. Be sure to watch your CardMail as well.

What's a 'To Do List'?

It's where our office (as well as other offices) put requests for information needed from you. It can be found via ULink. It's important to check it regularly so you can print and submit any forms listed, along with any required documentation, as soon as possible. Replying to requests quickly helps to ensure your eligibility for financial aid is evaluated in a timely manner. Your To Do List can be accessed under the Financial Aid section on the Student Services tab.

Filing the 2017-2018 FAFSA

If you have not already done so, now is the time to complete your 2017-2018 FAFSA online.

FAFSA IRS Data Retrieval Tool Unavailable

To protect sensitive taxpayer data, the IRS and Federal Student Aid (FSA) announced the Data Retrieval Tool on [fafs.gov](https://studentaid.ed.gov/sa/about/announcements/irs-drt-unavailable) will be unavailable until extra security protections can be added (<https://studentaid.ed.gov/sa/about/announcements/irs-drt-unavailable>). You can still file/update the FAFSA with your 2015 tax information, but you will have to enter those items using your 2015 tax return(s). If you were selected for the FAFSA Verification process you may have been told to utilize the Data Retrieval tool; however, due to this announcement, you may be required to submit a Tax Return Transcript or signed copy of tax return form instead. Please follow the instructions on your verification form and our website ([IRS Tax Return Transcript](#)) if you need to request a tax return transcript. Please contact our office if you have any questions or need assistance completing your FAFSA.

Summer Federal Work Study Program

As a reminder, the Federal Work Study Program is available to students who qualify during the Summer Semester. The eligibility requirements include:

- *Enrollment for at least 6 credit hours as an undergraduate student in a degree seeking program
- *Compliance with the Satisfactory Academic Progress Policy
- *A completed your 2016-2017 FAFSA and Early Request for Summer Federal Aid form

The pay rate for students in the 2017 summer program is \$8.25 per hour. The maximum number of hours you can work is 20 hours per week. The maximum student award is \$2700 for the summer. The program begins April 28, 2017 and ends August 17 2017.
