

# Ford Motor Company/EEOC Scholarship

**Deadline for Application: April 15**

This scholarship is awarded to minorities or women who have a connection to Ford Motor Company as an employee, an employee's spouse, or an employee's child (persons without a Ford connection will be considered ONLY in the event that no Ford Motor Company employee, their spouse, or children apply). Applicants must also be a resident of the Commonwealth of Kentucky, an undergraduate pursuing a first degree (graduates and post-bac's may be considered on an exception basis) at the University of Louisville, and must have demonstrated academic merit. Academic merit is as follows:

<u>Entering freshmen</u>	<u>Continuing UofL students</u>
High School GPA 3.0+	2.5 Cumulative College GPA
ACT composite 20+	

Transfer, non-traditional, post-bac, and graduate level students must have comparable proof of academic merit (to be received on individual basis).

**Application Procedure**

To apply for this scholarship, please submit the following:

1. A completed application for admission to the University of Louisville;
2. A high school transcript and ACT scores (other comparable documentation may be required if transfer, non-traditional, post-bac or graduate student);
3. This application form;
4. A letter requesting Ford Scholarship consideration;
5. A verification form explaining Ford Motor Company connection (if applicable). If no connection, please state in letter;
6. A letter of recommendation concerning the student's qualifications.
