Notes:

- A. Bundled Student Fees that will be charged to Tuition Remission participants are \$202/Semester for a Full-Time Student.
 - 1) Full-time load for all undergraduate courses is deemed to be 12 hours for the purpose of billing student fees, regardless of actual degree requirement.
 - 2) Full-time load for all graduate courses is deemed to be 9 hours for the purpose of billing student fees, regardless of actual degree requirement.
 - 3) Student Fees are calculated per credit hour and are rounded to the nearest whole dollar to promote efficiency in billing.
- B. Students will be responsible to pay all fees including student recreation fees, course or labs fees, and any other fees not bundled into tuition.
- C. For Dependent Children, the tuition differential that applies to on-line courses will also be billed to the student.
- D. For Graduate Business programs, the University covers 97-98% of the **pro-rated 6 hour charge**.
