In requesting that the University of Louisville Photographic Archives make available to me (us) the material requested, it is understood and agreed that:

1. The University of Louisville and the University of Louisville Photographic Archives make no representation whatsoever concerning any rights or consents to use, inspection, publication, reproduction, duplication or printing, in any manner of the aforesaid materials, and such use shall be at the sole risk and responsibility of the undersigned.
2. I (we) understand that copyrighted material can be reproduced only with the written permission of the copyright holder.
3. I (we) agree to defend and indemnify and save and hold harmless the University of Louisville, its Photographic Archives and their employees or designates, and the donors and former owners of Photographic Archives collections, from and of any and all costs, expense, damage and liability arising because of any claim whatsoever which may be presented by anyone for loss or damage or other relief occasioned or caused by the release of said negatives, prints, or photographs to the undersigned and their use in any manner, including their inspection, publication, reproduction, duplication or printing by anyone for any purpose whatsoever.
4. I (we) will not use or authorize others to use the said materials or copies furnished us for any purpose whatsoever, other than as herein indicated, without first obtaining the written consent of the University of Louisville Photographic Archives. I understand that these materials are not to be resold.
5. I (we) agree to pay the standard charges for services which may be furnished by the University of Louisville Photographic Archives.
6. I (we) agree to protect the rights and privacy of all subjects depicted in the materials furnished us. We are aware of the regulations regarding these rights which are contained in the Code of Federal Regulations, Title 45, Part 46, on Protection of Human Subjects, and will take all steps necessary to implement them.
7. I (we) agree that upon publication of said material we will indicate in an accompanying caption or label an appropriate credit and/or other information as specified by the University of Louisville Photographic Archives.
8. I (we) understand that in releasing said material the University of Louisville Photographic Archives does not surrender its rights to publish it, or to allow others to do so.
