SHOBHA JOSHI, MD

Dr. Joshi received her medical degree from the University of Bombay, India. After completing her Internal Medicine training at the Sinai Hospital of Baltimore and LSU Affiliated Program, she did her clinical and research Gastroenterology fellowship at Tulane University and the University of Pittsburgh.

She was an Associate Professor of Medicine at St. Louis University School of Medicine, where in addition to doing basic research, she took care of liver transplant patients and general hepatology patients.

In December 2008, Dr. Joshi joined Ochsner Clinic Foundation as Director of Hepatology Research and Transplant Hepatologist where she has incorporated the TeleECHO model to guide and educate providers on liver disease management, so they can manage their own patients for their hepatitis C or detection of Hepatocellular carcinoma

Fredric Regenstein, MD is the Medical Director of Liver Transplantation and a Professor of Clinical Medicine, Tulane University School of Medicine, New Orleans, Louisiana.

Dr. Regenstein received his MD degree from the Washington University School of Medicine. He completed his Internship and Residency in Medicine at Barnes Hospital, St. Louis, Missouri, and his Fellowship in Gastroenterology at Washington University School of Medicine.

Dr. Regenstein has more than 30 years of hepatology experience. His clinical and research interests include viral hepatitis, liver transplantation, and innovative therapies for hepatocellular carcinoma, cholestatic liver disease and nonalcoholic steatohepatitis. Dr. Regenstein is a Fellow of the American College of Gastroenterology and a member of the American Gastroenterological Association, AASLD, EASL, AST and the International Liver Transplant Society.



ELIZABETH BRITTON, MSN, APRN

Ms. Britton is the hepatology nurse practitioner for LSU Health Science Center in Baton Rouge, Louisiana. She coordinates the statewide hepatology specialty clinics for the state's incarcerated population, and staffs the LSUHSC hepatology specialty clinic at Our Lady of the Lake Regional Medical Center in Baton Rouge.
