I. Call to Order

Having determined a quorum present, Chair Porter called the meeting to order at 9:10 a.m. Chair Porter reported that Governor Ernie Fletcher presented UofL officials with a \$1 million check to help with the redesign of the Oval, (Third Street entrance to the Belknap Campus). Governor Fletcher presented the ceremonial check shortly after announcing \$5.3 million in state funding to build and improve the road infrastructure at UofL's Shelby Campus. The newly designed road network will provide additional traffic connections to help reduce congestion at the Hurstbourne Parkway and Shelbyville Road intersection. The project also will include aligning the primary Shelby Campus entrance with Whittington Parkway.

Approval of Minutes, February 21, 2007

Ms. Loving made a motion, which Mr. Poe seconded, to approve the minutes of February 21, 2007. The motion passed unanimously.

Chair Porter read the consent agenda. Hearing no objections, Ms. Abrams made a motion, which Mr. Butt seconded, to approve the agenda. Chair Porter noted the motion passed with Mr. Messer abstaining because he is a candidate for graduation and will receive his degree at the May commencement ceremony.

### III. Action Items on Approval of Tuition, Housing and Fees

#### Approval of 2007-2008 Tuition Rates

President Ramsey presented a powerpoint and explained the recommendation for a 9.9% tuition increase for 2007-08 for all categories except those noted below.

- Non-resident Graduate – Increase of 3.9%
- Non-resident Professional Medical – No Increase
- Professional MBA Program - \$28,000
- IMBA Program - \$25,000
- MAC Program - \$16,000
- IESL Program – The tuition will increase from \$2,225\* per 10 week term FY 2007 to \$3,700\* per semester FY 2008

The recommendation of 9.9% surfaced after much deliberation and consultation with the various constituency groups across campus. While many of the groups and committees had differing recommendations, the President decided to propose a tuition increase below double digits. Dr. Ramsey reminded the board that the Council on Postsecondary Education (CPE) held the statutory authority for setting tuition. The CPE delegated to the board of trustees authority to recommend a tuition schedule to the CPE for its final approval. The CPE met yesterday and awaits the University's final approval.

#### Approval of 2007-2008 Housing Rates

Provost Willihnganz introduced Ms. Shannon Staten, Director of Housing. Housing and Residence Life Program will continue to function as a full auxiliary unit. All revenue received from Bettie Johnson and Kurz Halls, less the cost of parking, will be used for current/future renovation projects and major repairs of the traditional halls. Occupancy rates for the residence halls averages 94%; the apartments average 85% throughout the fall and spring semesters.

#### Approval of Bundling Health Fee

President Ramsey reported that in its April 23, 2001 action, the Board of Trustees approved consolidating tuition and mandatory student fees into a single tuition amount. In a subsequent action on April 18, 2006 the Board approved a \$35 Health Fee for Belknap Campus students beginning Academic Year 2006-07. At that time a separate Health Fee of \$87.50 for selected health sciences students existed. The President stated the \$35 Student Health Fee provided many new health services and benefits not otherwise available to students. Implementation of the fee, however, was confusing to students. Also, the billing process was complicated and it became difficult to manage by the Student Health Services Office. Analysis of the fee assessment process, the impact on students and the

Student Health Services financial operations revealed that “bundling” the \$35 Student Health Fee for all University students would simplify the issues.

#### Approval of Speed School of Engineering Technology Fee

President Ramsey reported that beginning in Fall 2007, all incoming freshman students in the J.B. Speed School of Engineering will be required to have a tablet PC (a convertible notebook using pen-based technology). The tablet PC is a necessity for the implementation of Speed School’s initiatives to enhance the classroom environment. Discounted tablets will be available to the students through university-approved vendors. In order to provide needed software to the students at the lowest possible cost, Speed School has identified common general-purpose and engineering software packages. When all Speed Engineering School students are included, projected costs of the software for the students’ personal use are \$75 per year. This fee will purchase software with an estimated value of \$500, plus the licenses for free upgrades. Based on the typical three-term Speed academic year, a \$25 per semester technology fee is required to meet the software needs of the School’s students.

#### Approval of 2007-2008 Meal Plan Changes

President Ramsey reported the mandatory meal plans have remained the same since Fall 2004. The proposed increases will provide funding to expand operating hours and an additional location for a hot buffet meal on the west side of campus.

Mr. Messer acknowledged the tuition fee proposals honor the requests of the Student Government Association. Students were pleased the administration responded to their requests. He commended and thanked the administration for doing a great job. He noted there were two things students were concerned about with these increases: 1) measure of affordability and 2) what will the students receive for the increase. The administration maintained the increase below 10% and outlined the purpose for the fees and increases. Ms. Daly inquired about tuition remission and the bundling of the health fee. President Ramsey confirmed the fees will be paid by tuition remission. Ms. Loving made a motion, which Ms. Jackson seconded, to approve the

Updated on LMCDC

President Ramsey reported in March the UofL Foundation approved the potential inclusion of LMCDC as an affiliate. The President shared the powerpoint presentation made to the Foundation board of directors. President Ramsey said the LMCDC Board of Directors has passed a resolution to offer its assets and liabilities to the UofL Foundation, Inc. in order to strengthen the role of the University in the development of the health/life sciences research park. Taking over the management of the LMCDC will allow the University to coordinate its development of the Shelby Campus park with the downtown health sciences research park and to minimize competition in recruiting companies to either parks. The UofL Foundation Board of Directors authorized the President or his designee to negotiate with representatives of the Louisville Medical Center Development Corporation (LMCDC) the transfer of LMCDC assets and liabilities to the Foundation effective July 1, 2007. (Mr. Poe departed at 10:15 a.m.)

Highlights of the Powerpoint presentation include:

- Jewish Hospital Healthcare Service, Norton Healthcare, Inc., and University of Louisville founded LMCDC in 1997;
- The 2004 Strategic Plan was
  - \* To Make the Louisville Medical Center the next significant biomedical commercialization center in the U.S. and
  - \* Identified critical success factors;
- Goals for 2008 include increasing federal research funding to more than \$40 million annually and increasing total sponsored funding to \$80 million per year
- LMCDC purchased the Haymarket for \$4.9 million; selected Wexford as the developer in 2005; discussions on master lease with partners began in 2005; partners met in 2006; UofL performed due diligence

- Due diligence included discussions of possible tenants, discussions with the State and with Wexford; review of options for UofL's role

#### SACS Accreditation Update

President Ramsey reported the University will host the SACS accreditation site visit next week. Provost Willihnganz and her staff have done an excellent job in preparing for the accreditation process. President Ramsey asked Provost Willihnganz for a briefing. Provost Willihnganz distributed the Quality Enhance Plan's "Ideas to Action: Using Critical Thinking to Foster Student Learning and Community Engagement" booklet. Provost Willihnganz thanked Dr. Dan Mahoney and Ms. Connie Shumake for their leadership and commitment to this project. (Ms. Jackson departed at 10:50 a.m.)

#### Signature Partnership

President Ramsey asked Vice President Hall for a briefing on the Signature Partnership initiatives. Vice President Hall distributed an update on the Signature Partnership Initiative Programs. He noted involvement of various community partners and residents to improve west Louisville. Initiatives include health initiatives, economic development initiatives and social service projects. Over 200 students from the University are engaged in these initiatives. Mr. Hall thanked President Ramsey and Provost Willihnganz for their support. He also noted the support of the deans.
