Executive Vice President and Provost Willihnganz reported that various academic units within the university have educational affiliations with international institutions. Initially, the departments and deans endorse all of the affiliation agreements before legal counsel reviews. The Provost's office provides administrative oversight for academic programs and international affairs. For expediency and efficiency, it is anticipated, at this time, that the Vice Provost for Diversity and Equal Opportunity be delegated the authority to sign international educational affiliation agreements, upon the preparation of an official letter of delegation from the President and Provost. Ms. Abrams made a motion, which Prof. Laning seconded, to approve the

**President's recommendation that the signature authority for international educational affiliation agreements be delegated, with the appropriate documentation, by the President and/or Provost to the appropriate individual within the office of the Provost.**
