### Approval of Minutes

The minutes of March 3, 2006 were approved.

### Report on Assessment Process

B. Williams reported on the second semester of readings. A total of 182 readings covered three competencies (critical thinking, effective communication, and cultural diversity) for Anthropology, Health & Sport Sciences, Sociology, and Pan-African Studies. In preparation for the September SACS report, the numbers will be evaluated over the summer and combined with the data collected in January. There are implications for the cultural diversity competency. In the fall, readings are targeted for Philosophy, Women and Gender Studies, Modern Languages, and upper-level English courses. Also, the Mathematics assessment rubric will be discussed. Next spring, the focus will be on the Natural Sciences disciplines. Michelle Bachelor was applauded for her work regarding the assessment process.

# Change in CD Designation for Nursing Course

Bays reported on curriculum changes in the School of Nursing that will impact a cultural diversity course designation. Effective Fall 2006, NURS 340 (a CD1 course\*\*) will no longer be offered. The content will be divided into 3 separate courses, specifically Nursing 341, 342, and 343. The NURS 341 course will retain the previously approved cultural diversity content from Nursing 340 but will reflect a title change. The GECC had no problem with these changes, which affect Nursing students only.

#### Report on Blackboard Caliper Project
