Colleagues:

I am glad to announce that Dr. Beth Boehm, dean of the School of Interdisciplinary and Graduate Studies and vice provost for graduate affairs, has agreed to add undergraduate program development and policies to her responsibilities, including the oversight of the Cardinal Core, the new general education program that has now been approved by all units. With these additional responsibilities, her new title will be **vice provost for academic affairs, and** she will retain her title as dean.

She and Jim Begany, vice provost for strategic enrollment management and students success, will work together with the deans on graduate and undergraduate student success; they will also both advise the deans of the professional schools on areas of common concern. The Delphi Center, the undergraduate mentored scholarship programs and the 2017 QEP will continue to report directly to the provost. As a consequence of these changes, the title and office of the vice provost for undergraduate affairs will be suspended.

I am grateful for Dr. Boehm's willingness to take on this additional assignment, and I know you share the belief that the university's academic programs, undergraduate and graduate, will thrive under her thoughtful care.
