### MINUTES OF THE JANUARY 13, 2017, MEETING OF THE CURRICULUM COMMITTEE

The meeting was convened at 2:06 PM.

The committee approved the minutes of the November 11, 2016, meeting.

#### **NEW BUSINESS:**

77-16F: The Curriculum Committee APPROVED the Department of Sociology's request to change SOC 360's title, course number, prerequisites and to give the course a CUE designation. SOC 360 will be renumbered as SOC 435. Its new title will be "Medicine, Health, and Illness—CUE" and its new prerequisites will be successful completion of SOC 201 and 323, 9 hours of social science course work at the 300+-level or permission of the instructor.

78-16F: The committee APPROVED changing SOC 374's title to "Money, Economics, and Society."

**79-16F:** The committee **APPROVED** granting CUE status to SOC 400, "Independent Study." The course's official title will be changed to "Independent Study—CUE."

**80-16F:** The committee **APPROVED** the deletion of SOC 401, "Internship in Sociology." With its deletion, students pursuing the BS in Sociology will be required to take SOC 405.

**81-16F:** The committee **APPROVED** designating SOC 406 as a CUE course. Its title will be changed to "Applied Sociology—CUE" to reflect this change.

**82-16F:** The committee **APPROVED** designating SOC 410 as a CUE course. It also **APPROVED** changing the course's prerequisites. Its new title will be "Sociology of Aging—CUE" and its new prerequisites will be completion of SOC 201 and 323, 9 hours of social science course work at the 300+level or permission of the instructor.

**83-16F:** The committee **APPROVED** designating SOC 415 as a CUE course. Its new title will be "Sociology of Death and Dying—CUE."

**84-16F:** The committee **APPROVED** designating SOC 425 as a CUE course. Its new title will be "Sociology of Leisure—CUE."

**85-16F:** The committee **APPROVED** designating SOC 440 as a CUE course. Its new title will be "The Health Care System—CUE."

**86-16F:** The committee **APPROVED** designating SOC 450 as a CUE course. Its new title will be "Special Topics in Sociology—CUE."

- 92-16F: The committee APPROVED the deletion of SOC 490, "Topical Seminar."
- **93-16F:** The committee **DEFERRED** designating SOC 480 as a CUE course, pending submission of a revised syllabus. The committee agreed that the course does not seem to require enough synthetic work to be a CUE. Concerns were particularly focused on the fact that the final reflection paper is only worth 5% of the course grade.
- **94-16F-96-16F:** The committee **APPROVED** the addition of UPA 663, PLAN 663, and PADM 683, "Social Equity and the Public Sector."
- **97-16F:** The committee **APPROVED** the addition of UPA 652, "Urbanism in the Global South: Cities and Space." The course will be cross-listed with GEOG 510 and LALS 510.
- **98-16F:** The committee **APPROVED** changing the cross-listing for GEOG 510 to reflect its cross-listing with UPA 652. Its description was also changed to reflect the new cross-listing.
- **99-16F:** The committee **APPROVED** changing the cross-listing for LALS 510 to reflect its cross-listing with UPA 652. Its description was also changed to reflect the new cross-listing.
- 100-16F-102-16F: The committee APPROVED the addition of PADM 664/PLAN 664/UPA 664, "Cultural Competency and Action."
- **103-16F-104-16F:** The committee **APPROVED** the addition of UPA 650/PADM 650, "Urban Policy and Administration."
- 105-16F: The committee APPROVED the addition of UPA 608, "Regression Analysis."
- **106-16F:** The committee **DEFERRED** approval of SUST 518, "Urban Demography and GIS," pending final approval of the undergraduate SUST curriculum. The proposed course, if approved, will be cross-listed with PLAN 618.
- 107-16F: The Department of Sociology proposed changes to its master's degree program. The proposed changes are intended to streamline time to completion and "require more quantitative and qualitative methods courses, and culminate in a 30-page article-length paper defended during the fourth semester." The department proposed that several courses be renumbered from the 700-level to the 600-level "to better reflect the nature of the course" and that several courses be retitled to reflect the new curriculum. The proposed new curriculum was **APPROVED** by the committee and appears below.
