MINUTES OF THE DECEMBER 3, 2019, MEETING OF THE CURRICULUM COMMITTEE

The meeting was convened at 10:02 AM.

The committee unanimously approved the minutes of the November 8, 2019, meeting.

062-19F: Associate Dean for Graduate Education David Brown presented proposed changes to A&S Minimum Guidelines for Graduate Education. The new language was created to ensure consistency with changes adopted by the Graduate School. The College's minimum guidelines were reformatted to match the Graduate School's format and language describing the process for approving external committee appointments was clarified. The original and revised documents appear in the appendix below. The committee **APPROVED** the proposed changes, will be advanced to the Faculty Assembly for its review and approval.

063-19F: Comparative Humanities proposed changes to the BA in Comparative Humanities. Students currently must complete HUM 105 as part of the major. Under the proposed change, students would be able to take HUM 105 or HUM 152. The committee **APPROVED** the request.

064-19F: The committee **APPROVED** the Department of Comparative Humanities' request to correct an error in its Film Studies track. Students in the track are required to complete HUM 326, but the course also appeared as a track elective option. It will be removed during the next round of catalog revisions.

065-19F: The committee **APPROVED** the Department of Comparative Humanities' request to revise the Jewish Studies minor. Students will now be able to take HUM 220, "Introduction to Jewish Cultures," as an elective option in both the Jewish Cultural Studies and the Jewish Language and Culture options.

066-19F: The committee **APPROVED** a proposed change to HUM 595's description. The new course description will read "The study of major systematic views of the development of Western culture in a global context. Note: Approved for the Arts and Sciences upper-level requirement in written communication (WR). Note: Credit may not be received for this course and HIST 595."

067-19F: Comparative Humanities proposed a series of changes in its MA to standardize departmental offerings. First, the department proposed to create a thesis option within all graduate tracks (currently the thesis option is only available in the Interdisciplinary Humanities track). This will be accomplished by adding HUM 645 ("Thesis Guidance") as an option in each track. Second, the department proposed to make a change to the Public Humanities track. The track currently requires two internships, one internal and one external. The department wished to require only the external internship and to replace the lost three credits with another course. The committee reviewed a curricular mock-up that Dr. Pruitt prepared based on the department's submission, but questions were raised about the proposed changes that could not be addressed since Dr. Bertacco was unable to attend the meeting. The committee asked Dr. Pruitt to get some clarification about the department's intentions before it makes its final decision.

- **068-19F:** The committee **APPROVED** Comparative Humanities' request to remove the course's crosslisting with ANTH 383, which no longer exists.
- **069-19F:** Fine Arts requested to replace the requirement that its students take a course from the HUM 591-596 courses to a requirement that students complete any 400- or 500-level WR course in the humanities. This course will impact all ART and ARTH majors. The committee **APPROVED** Fine Arts' request.
- **070-19F:** The committee **APPROVED** Communication's request to remove COMM 201 as a prerequisite for COMM 338, "Introduction to Film Production."
- **071-19F:** The committee **APPROVED** Communication's request that COMM 412 be designated as a WR course.
- **072-19F:** The committee **APPROVED** English's request that ENGL 300 be retitled as "Introduction to Literature-WR" and that its description be changed. It will now read "An introduction to literature, providing an overview of forms such as poetry, drama, and the novel, and an introduction to terminology and methods using in analyzing texts." This course will be part of the English major core under a forthcoming revision to the department's undergraduate curriculum.
- **073-19F:** The committee **APPROVED** proposed changes to ENGL 301's title, description, and prerequisite. The new title will be "Literature in English before 1800." The new description will be "Surveys early British and early American writers before 1800." The new prerequisite will be ENGL 300.
- **074-19F:** The committee **APPROVED** proposed changes to ENGL 302's title, description, and prerequisite. The new title will be "Literature in English after 1800." The new course description will be "Introduces literary texts in English since 1800, with a focus on US, British, and diasporic authors writing in the English language." The new prerequisite will be ENGL 300.
- **075-19F:** The committee **APPROVED** proposed changes to ENGL 310's title and description. The new title will be "Introduction to Professional and Public Writing." The new course description will be "Introduces students to the nature of, and practices involved in, becoming a professional/public writer."
- **076-19F:** The committee **APPROVED** the creation of ENGL 315, "Culture, Text, and Media," a new course to be part of the English major's required core.
- **077-19F:** The committee **APPROVED** the creation of ENGL 405, "Editing, Publishing, and Document Design."
- **078-19F:** The committee **APPROVED** the creation of ENGL 407, "Writing for Social Change," pending submission of a revised syllabus that includes a grading scale and that explains how informal writing assignment discussed in the syllabus figure into students' final grades.
- 079-19F: The committee APPROVED the creation of ENGL 425, "Literature and the Environment."
- **080-19F:** The committee **APPROVED** the creation of ENGL 480, "Digital and Visual Composition."
- **081-19F:** The committee **APPROVED** the creation of ENGL 509, "Special Topics in Writing," pending submission of a revised syllabus featuring a grading scale.
- **082-19F:** The committee **APPROVED** English's proposed changes to ENGL 599's title and description. The course's new title will be "Texts and Technologies-WR, CUE." Its new description will be "Examines

how shifting and emergent technologies (related to types of writing, printing, paper-making, advertising, digital environmental, as well as to historical and contemporary communication and distribution networks) shape authorship and literary work/reception."

083-19F: The Department of Urban and Public Affairs proposed several changes to its MPA program. First, the Sustainable Urban Development specialization will be removed. Second, the term "specialization" is being replaced by the term "concentration" in accordance with recommendations from NASPAA, the program's accrediting organization. Third, the program will no longer require the GRE for admission. NASPAA does not require it and peer institutions have discovered eliminating the requirement has positively impacted their recruitment. Fourth, the program will add a Diversity Management and Leadership Concentration. Finally, the MPA faculty proposed a restructuring of the degree program to consist of seven required courses (PADM 600, 601, 603, 606, 624, 642, and 664), 4 courses within the concentration, 1 program elective, and six hours of internship/practicum or thesis for a total of 42 hours. The committee **APPROVED** all of the proposed changes.

084-19F and 085-19F: The committee **APPROVED** the creation of CJ/SCHG 510, "Managing Conflict, Change, and Justice."

086-19F: The committee **APPROVED** the Department of Psychological and Brain Sciences' request to change PSYC 301's description and prerequisites. The course's new description will be "Elementary statistical methods as applied in the social sciences: probability; distribution (theoretical and empirical); statistics and parameters; sampling; tests of hypotheses including ANOVA; regression and correlation; contingency." The new prerequisite will be PSYC 201 AND completion of the QR requirement with grade of C or higher. The Curriculum Committee would like to follow-up with the department to see if it will students who satisfied the QR requirement through AP or CLEP work to register for PSYC 301.

087-19F: The committee **APPROVED** PSYC's proposed changes to PSYC 372, "Social Psychology." The course will be renumbered as PSYC 312. Its new description will be "Major topics relevant to people as social beings; social learning and personality development, social influences in perception and cognition, interpersonal communication and influence, small group behavior, and mass behavior."

088-19F: The committee **APPROVED** PSYC's request to renumber PSYC 375, "Personality," as PSYC 315. Its new description will be "A review of major personality theories in terms of experimental and clinical findings."

089-19F: The committee **APPROVED** changing PSYC 400's prerequisites to make prerequisites consistent across all PSYC CUE courses. The prerequisites will now be "PSYC 201, PSYC 301, PSYC 302; approved Psychology major; 90 earned hours total, including at least 24 hours in Psychology; or permission of instructor."

090-19F: The committee **APPROVED** changing PSYC 430's prerequisites to make prerequisites consistent across all PSYC CUE courses. The prerequisites will now be "PSYC 201, PSYC 301, PSYC 302; approved Psychology major; 90 earned hours total, including at least 24 hours in Psychology; or permission of instructor."

091-19F: The committee **APPROVED** PSYC's request to renumber PSYC 432, "Vision and Art," as PSYC 335.

092-19F: The committee **APPROVED** renumbering PSYC 485 and updating its prerequisites to make them consistent with all PSYC CUE courses. PSYC 485 will be renumbered as PSYC 442. The prerequisites will now be "PSYC 201, PSYC 301, PSYC 302; approved Psychology major; 90 earned hours total, including at least 24 hours in Psychology; or permission of instructor."

093-19F: Psychological and Brain Sciences proposed changing its departmental admission requirements to be the following: 1) Completion of PSYC 201 with a minimum grade of C; 2) Completion of any approved QR course with a minimum grade of C; 3) Completion of PSYC 301 or department-approved substitute with a minimum grade of C; 4) Completion of PSYC 302 with a minimum grade of C; 5) Completion of 30 hours of degree-applicable credit with a minimum grade point average of 2.0; and 6) a minimum grade point average of 2.0 in Psychology. The committee **APPROVED** PSYC's proposal.

094-19F: Psychological and Brain Sciences proposed changing its minor's admission requirements to the following: 1) Completion of PSYC 201 with a minimum grade of C; 2) Completion of any approved QR course with a minimum grade of C; 3) Completion of PSYC 301 or department-approved substitute with a minimum grade of C; 4) Completion of 30 hours of degree-applicable credit with a minimum grade point average of 2.0; and 5) a minimum grade point average of 2.0 in Psychology. The committee **APPROVED** PSYC's proposal.

095-19F: Psychological and Brain Sciences proposed change to its BA and BS curricula. Under this proposal, all PSYC electives must be taken at the 300+-level. Students will not be able to use PSYC 205 as a major elective.
