MEETING OF THE CURRICULUM COMMITTEE December 6, 2022 MINUTES

The meeting was convened via MS TEAMS at 9:30 AM and the November 11, 2022 minutes were approved.

Dr. Jason Sievers informed the Committee of curriculum changes since November 11th (Appendix A).

- **028-22F** The Committee **APPROVED** the new course SPAN 370: Introduction to Interpreting. Drs Regina Roebuck and Marc Tamarit Galdon informed the Committee the purpose of the course to introduce theoretical and practical foundations of Interpreting in community settings, including social, medical, legal, education settings. In addition, it provides an overview of the interpreting activity and profession by focusing on the different interpreting modes, settings and techniques; professional role and professional ethics, standards of practice, decision-making and dilemma-solving strategies and other tools to help students grasp and practice interpreting. *Next steps: Send to Bob Goldstein*.
- **029-22F** The Committee **APPROVED** the new course PHIL 541: Recent Topics in the Philosophy of Language. Dr. Avery Kolers informed the Committee that the course is to survey and discuss various interdisciplinary research on these topics with an eye to answering the initial philosophical question. *Next steps: Send to Bob Goldstein.*
- **030-22F** The Committee **APPROVED** the new course: PHIL 584: Clinical Ethics. Dr. Avery Kolers informed the Committee of the purpose of the course is to familiarize learners with the basic modes and styles of ethics consultation in clinical settings. Students will study policy development and educational aspects of hospital ethics committees as well as apply philosophical and sociological concepts to cases and policy in clinical settings and will consider methods of mediation. *Next steps: Send to Bob Goldstein*.
- 031-22F The Committee APPROVED the proposed curricular changes: Degree and Track Requirements in the Philosophy Major. Dr. Avery Kolers informed the Committee the Philosophy Department is in the process of correcting their major and tracks. For the History of Philosophy sequence (PHIL 301, 302, 303, 304, 306, 307, 385, 572) the department wants to expand the degree requirements to: any two of 301, 303, 304, 306 and expand the track requirements to include 301, 303, and 304, with language clarifying that a course may not count for both a degree requirement and a track requirement. For the Bioethics track allows students to incorporate the pre-med science curriculum. Unfortunately, that curriculum has expanded to 39 credits (minimum; 42 recommended), which makes it very hard for students to complete it and still have room for the major. For the Bioethics in the Degree requirements (i.e., for all tracks), allow students to take a Statistics course in place of Logic. This is helpful because the Pre-med Science curriculum recommends statistics. New requirement should read: Take one of PHIL 311, PHIL 412, BIOL 350, CJ 326, MATH 109, PHST 301, PSYC 301, SOC 301. Finally in the track requirements for the Bioethics track, add BIOL 540 to the Supporting Course list. (Biochemistry is now required in the Pre-med science curriculum). Next steps: Send to Bob Goldstein.
- **032-22F** The Committee **APPROVED** the proposed curricular changes in Sociology. Specifically in the MA program and the Accelerated BA-BS/MA in Sociology Application Procedure. Jonetta Weber informed the Committee of the changes to the MA program and the Accelerated BA-BS/MA in Sociology Application Procedure which includes adding SOC 206 to meet one of the core requirements in the major. This allows, the BA (no track), BA (track in sociology of culture), BA (track in diversity and inequality), BS (no track), and BS (track in health/medicine/well-being) degrees would all allow students to take SOC 202 or 206 or 210.). In addition, Sociology is updating the wording in the catalog regarding application to their MA and accelerated MA program. *Next steps: Send to Bob Goldstein*.

- **033-22F** The Committee **APPROVED** the proposed new concentrations in the Master of Urban Planning (MUP) program. Dr. Matthew Ruther informed the Committee the reason why adding the two new concentrations (Sustainability and Community Development). Specifically, they are the replacement of the four old ones because (1) many courses are not offered due to personnel changes, (2) it becomes increasing difficult to maintain four concentrations given the declining enrollment, (3) two old concentrations (Administration of Planning Organization and Spatial Analysis) have no demand, and (4) there is a need to take advantage of the growing talent in sustainability within the department. *Next steps: Send to Bob Goldstein*.
- **034-22F** The Committee **APPROVED** the new course GEN 401: General Studies Capstone (CUE/WR). Dr. Joe Grant explained to the Committee the course is a "capstone course" for the General Studies Program fulfilling the University's "Culminating Undergraduate Experience" requirement for graduation. *Next steps: Send to Bob Goldstein.*
- **035-22F** The Committee **APPROVED** the new course CJ 304: Criminal Justice Prior Learning Assessment. Drs. Thomas Hughes and Joe Grant explained to the Committee the purpose of the course which is to provide students with knowledge and skills to document and assess prior learning from occupational training. Documentation and reflection writing are combined in a PLAD (Prior Learning Assessment Documents) which is evaluated for award of college credit. Writing, thinking and technology skills are emphasized. *Next steps: Send to Bob Goldstein.*
- **036-22F** The Committee **APPROVED** the new course BIOL 321: Introduction to Heath Professions Skills Laboratory. Dr. Paul Himes explained to the Committee that this course is part of a new certificate program that Biology is developing in collaboration with the School of Public Health. *Next steps: Send to Bob Goldstein*.
- **037-22F** The Committee **APPROVED** the new course BIOL 322: Healthcare Workforce Internship I. Dr. Paul Himes explained to the Committee that this course is part of a new certificate program that Biology is developing in collaboration with the School of Public Health. *Next steps: Send to Bob Goldstein*.
- **038-22F** The Committee **APPROVED** the new course BIOL 323: Healthcare Workforce Internship II Dr. Paul Himes explained to the Committee that this course is part of a new certificate program that Biology is developing in collaboration with the School of Public Health. *Next steps: Send to Bob Goldstein*.
- **039-22F** The Committee **APPROVED** the new course ART 594: Directed Projects in Design. Dr. Christopher Reitz informed the Committee the course is about navigating ambiguous charters while giving the students the opportunity to express themselves as they combine media, approaches, and forms from across your coursework in art and design. *Next steps: Send to Bob Goldstein*.
- **040-22F** The Committee **APPROVED** the proposed curricular change: DES Design Courses Designation. Dr. Christopher Reitz informed the Committee the reason behind changing the Design Course designations from ART to DES. *Next steps: Send to Bob Goldstein.*
- **041-22F** The Committee **APPROVED** the proposed Department of Communication new Accelerated MA Program Proposal. Dr. Nicholas Paliewicz explained to the Committee the Accelerated Master of Arts program would allow upper-level undergraduate students (juniors and seniors), if accepted to the program, take a maximum of 9 credit hours of courses in the Department of Communication that count for both undergraduate and graduate accreditation. The following classes will be made available for students that have not yet completed their Bachelor of Arts/Science degree for both undergraduate and graduate credit:
 - Ethical Problems (COMM 506, CUE, WR)
 - Communication Criticism (COMM 412, CUE, WR)
 - Advanced Intercultural Communication (COMM, 450, CUE, WR)
 - Crisis Management (COMM 510)
 - International Communication (COMM 510)
 - Other select classes cross-listed at the 400 and 500 levels

Next steps: Send to Bob Goldstein.

042-22F – The Committee **APPROVED** the new course COMM 343: Photography and Cinematography Production. Dr. Nicholas Paliewicz explained to the Committee that this course has been taught as special topics for several years and the instructor wishes it to be in catalog. *Next steps: Send to Bob Goldstein*.

043-22F – The Committee **APPROVED** the new course COMM 355: Health and the Media. Dr. Nicholas Paliewicz explained to the Committee that the Department wants to add this course to the catalog after several years of teaching as special topics. In addition, it was noted that this course has good enrollment. *Next steps: Send to Bob Goldstein.*

044-22F – The Committee **APPROVED** the proposed course change: COMM 375: Communication and the Environment. Dr. Nicholas Paliewicz explained to the Committee the reason why this course is being lowered to the 300 level and removing the CUE designation (Department has too many CUEs and not enough at 300 level) which they believe will help increase enrollment. *Next steps: Send to Bob Goldstein*.

045-22F – The Committee **APPROVED** the proposed course change: COMM 385: Rhetoric in Civic Life – WR. Dr. Nicholas Paliewicz explained to the Committee the reason why this course is being lowered to the 300 level and removing the CUE designation which they believe will help increase enrollment. *Next steps: Send to Bob Goldstein.*

046-22F – The Committee **APPROVED** the proposed course change: COMM 390: Political Communication. Dr. Nicholas Paliewicz explained to the Committee the reason why this course is being lowered to the 300 level which is to be more appropriate for the content of the course. *Next steps: Send to Bob Goldstein*.

Dr. Jason Sievers informed to the Committee, they are responsible for selecting the awardees for the College Awards for Distinguished Teaching, Teaching Innovation, and the Graduate Student Excellence in Teaching awards. The timeline for selecting the awardees:
