

MINUTES OF THE DECEMBER 4, 2018, MEETING OF THE CURRICULUM COMMITTEE

The meeting was convened at 9:31 AM.

The committee unanimously approved the minutes of its November 9, 2018, meeting.

OLD BUSINESS:

075-18F: The committee **APPROVED** the creation of PHIL 325, "Feminist Medical Ethics," after reviewing a revised syllabus that eliminated language the committee questioned at its November 9, 2018, meeting.

NEW BUSINESS:

093-18F: The committee **APPROVED** the Department of Theatre Arts' request that TA 349, "Introduction to Stage Lighting," be renamed "Introduction to Lighting Design" effective Summer 2019.

094-18F: The committee **APPROVED** Theatre Arts' request that TA 362, whose title was approved to be changed to "Theatre History and Script Analysis III: Modern and Contemporary" at the committee's October 2018 meeting, be designated as a WR course effective Summer 2019. The course's description will also be updated to reflect the course's content and place in the revised departmental curriculum approved in October.

095-18F: The committee **APPROVED** the addition of TA 380, "Introduction to Voice and Movement," effective Summer 2019.

096-18F: The committee **APPROVED** changing SOC 455's title from "Occupations and Organizations" to "Sociology of Work." The committee also **APPROVED** the department's request to change the course's prerequisites to "SOC 201, SOC 320, and SOC 323; 9 hours at 300+-level in one social science; or consent of the instructor." This change will be effective Summer 2019.

097-18F: The committee **APPROVED** changing SOC 631's title from "Sociology of Work and Organizations" to "Sociology of Work," effective Summer 2019.

098-18F: The committee **APPROVED** the addition of SOC 451, "Special Topics in Sociology-WR, CUE," effective Summer 2019.

099-18F: The committee **APPROVED** the Department of Sociology's request that SOC 480, "Juvenile Delinquency," receive a CUE designation. The course's official title beginning in Summer 2019 will be "Juvenile Delinquency-CUE."

100-18F: The committee **APPROVED** changing the course description and prerequisites for SOC 695, "Research Study," effective Summer 2019. Until now, the course had no course description. The new course description will be "This course provides an opportunity for students to finish their research study

and defend it before a faculty committee.” The prerequisite will be “consent of director of graduate studies.”

101-18F: The committee **APPROVED** changing the prerequisites for SOC 706, “Doctoral Exam Preparation,” to “consent of director of graduate studies,” effective Summer 2019.

102-18F: The committee **APPROVED** the deletion of SOC 707, “Internship Preparation,” effective Summer 2019.

103-18F: The committee **APPROVED** the deletion of SOC 708, “PhD Internship,” effective Summer 2019.

104-18F: The committee **APPROVED** the Department of Sociology’s requested curricular change to the MA in applied sociology. This change would replace SOC 615, “Seminar in Research Methodology,” with SOC 690, “Independent Study” or an elective during the first semester of the first year. No other changes will be made to the existing curriculum. These changes will be effective Summer 2019.

105-18F: The committee **APPROVED** changing the prerequisites for SOC 618, “Qualitative Research Methods.” The department is removing “SOC 615 or consent of instructor,” effective Summer 2019.

106-18F: The committee **APPROVED** changing the prerequisite for SOC 622, “Survey Research and Design.” The department is removing “SOC 615 or consent of instructor,” effective Summer 2019.

107-18F: The committee **APPROVED** the addition of ART 559, “Computer Applications for Interiors I,” effective Summer 2019.

108-18F: The committee **APPROVED** changing the title of ART 569, “Computer Applications in Interior Design,” to “Computer Applications for Interiors II.” Effective Summer 2019.

109-18F: The committee **APPROVED** changing the curriculum for the BFA in Interior Design to reflect the creation of ART 559. ART 559 will be added to the Interior Design core, effective Summer 2019.

110-18F: The committee **APPROVED** Fine Arts’ request to change ART 566’s class component code from LAB to LEC and to remove the \$50 course fee. Effective Summer 2019.

111-18F: The committee **APPROVED** changing ART 567’s class component code from LAB to LEC and to remove the \$50 course fee. Effective Summer 2019.

112-18F: The committee **APPROVED** changing ART 568’s class component code from LAB to LEC and to remove the \$50 course fee. Effective Summer 2019.

113-18F and 114-18F: The committee **APPROVED** changing the title, description and prerequisites for ART 578, “Video.” The new title will be “Image and Installation;” the new description will describe more accurately and completely the course’s content; and the new prerequisite will be ART 351 and BFA candidacy or faculty consent.” As item 114-18F, the committee **APPROVED** adding a graduate version of the course. Effective Summer 2019.

115-18F: The committee **APPROVED** the addition of ART 588, “Internship in Graphic Design.” Effective Summer 2019.

116-18F: The committee **APPROVED** changing ART 597, “Professional Development in Studio Arts-CUE” from a 1-credit course to a 3-credit course, effective Summer 2019.

117-18F: The committee **APPROVED** necessary editorial changes to the curricula in the BFA in 2D and 3D Studios after approving the requested change to ART 597. The 2D Studios and 3D Studios Studio Art BFA track will now require 18 hours, up from 15, which increases the total number of hours required to 33.

118-18F: Matt Ruther and David Simpson presented the proposed BA in Urban Studies. The proposed interdisciplinary major will be a partnership between the Departments of Urban Affairs, Geography and Geosciences, and Sociology. Majors would complete an Urban Studies core, which will consist of five new courses (URBS 101: The Making of Urban Places; URBS 102: Discover Louisville; URBS 201: Principles of Urban Planning; URBS 202: Foundations of Urban Administration; and URBS 404: Internship in Urban Studies-CUE) and four existing courses to be cross-listed as URBS courses (SOC 305: Urban Sociology, GEOS 328: Urban Geography, PLAN 604: Urban Data Analysis, and PLAN 618: Urban Demography and GIS). The remainder of the major would consist of a 12-hour concentration in Urban Administration, Urban Geography, Urban Planning, or Urban Sociology and 12 hours of guided electives taken from a list of urban-themed or thematically-aligned social sciences courses. Students would then have to complete 29 hours of electives. Corrections were requested to the proposal's example flight plan, found on page 16. The plan is missing a Natural Sciences lab, needs to replace one SB course with an SBH course. A BA degree requires completion of 12 credit hours in foreign language, not the six indicated in the proposal. The committee also recommended that the QR course be moved from its current placement in semester 6 to earlier in the major. Editorial revisions were also requested on page 9 to replace "Justice Administration" with "Criminal Justice," on page 10 to replace "Dean Kimberly Leonard" with "Dean Robert Fox," and on page 18 to replace "URBS 318" with "URBS 518." The committee **APPROVED** the proposal, which will also be reviewed by the dean and the Planning and Budget Committee before moving to the A&S Faculty Assembly.

119-18F: The committee **APPROVED** the deletion of COMM 255, "Communication Practices," effective Summer 2019.

120-18F: The committee **APPROVED** changing COMM 320's prerequisite from COMM 201 to ENGL 102 or ENGL 105, effective Summer 2019.

121-18F: The committee **APPROVED** changing COMM 321's prerequisite from COMM 201 to ENGL 102 or ENGL 105, effective Summer 2019.

122-18F: The committee **APPROVED** changing COMM 322's prerequisite from COMM 201 to ENGL 102 or ENGL 105, effective Summer 2019.

123-18F: The committee **APPROVED** changing COMM 323's prerequisite from COMM 201 to ENGL 102 or ENGL 105, effective Summer 2019.

124-18F: The committee **APPROVED** designating COMM 412, "Communication Criticism," as a CUE course. Its new official title, effective Summer 2019, will be "Communication Criticism-CUE."

125-18F: The committee **APPROVED** the deletion of COMM 421, "Communication Technologies," effective Summer 2019.

126-18F: The committee **APPROVED** the deletion of COMM 428, "Advanced Video," effective Summer 2019.

127-18F: The committee **APPROVED** the addition of COMM 421, “Documentary Production-CUE,” effective Summer 2019.

128-18F: The committee **APPROVED** designating COMM 430, “Health Communication-WR,” as a CUE course. Its new official title, effective Summer 2019, will be “Health Communication-WR CUE.”

129-18F: The committee **APPROVED** the Department of Biology’s proposed revision to the Genetics/Subcellular and Cellular Physiology tracks in the BS in Biology, effective Summer 2019. The department wishes to merge these tracks to create the Molecular, Cellular, and Developmental (MCD) Biology track. With this change, there will only be two tracks in the BS in Biology, the MCD track and the Ecology track. The new curriculum for the MCD track appears below:

131-18F: The committee **APPROVED** changing BIOL 404’s title and prerequisites. The department wishes to remove the CUE designation from this course, so its new official title will be “Undergraduate Research.” Its new prerequisites will be “Faculty and chair consent; minimum 30 credit hours; 3.0 cumulative GPA.” Effective Summer 2019.

132-18F: The committee **APPROVED** changing BIOL 405’s title and prerequisites. The department wishes to add the CUE designation to this course, so its new official title will be “Undergraduate Research-CUE.” Its new prerequisites will be “Faculty and chair consent; minimum 30 credit hours; 3.0 cumulative GPA.” Effective Summer 2019.

148-18F: The committee **APPROVED** the proposed description and prerequisite changes for GEOS 360, “Global Environmental Change.” The new description more accurately reflects how the course is currently taught. The course will now no longer have a prerequisite, though students are advised to have taken “a general physical or environmental introductory course” prior to enrolling. The description suggests GEOS 200, ANTH 202, BIOL 240 or PHYS 220. Effective Summer 2019.

149-18F: The committee **APPROVED** designating CHEM 420, “Cooperative Internship in Chemistry-WR,” as a CUE course. Its new official title will be “Cooperative Internship in Chemistry-WR, CUE.” Effective Summer 2019.

150-18F: The committee **DEFERRED** approval of the addition of CHEM 555, “Computational Chemistry.” The course is proposed for both graduate and undergraduate credit, but the syllabus does not differentiate between expectations for graduate and undergraduate students.

151-18F: The committee **APPROVED** the Department of Classical and Modern Languages’ request to clarify the College’s foreign language requirement. The requirement is that students complete “the intermediate level of a single foreign language,” not that they take 12 hours of foreign language at UofL. This will require that each major be updated in the CourseLeaf catalog such that BA programs will indicate that students will need to complete 3-12 hours in a foreign language and that students in BS programs will have to complete 3-8 hours in a foreign language, depending on their language placement.

The meeting was adjourned at 11:13 AM.
