KIESE LAYMON 17th Annual Anne Braden Memorial Lecture

We are thrilled to announce Kiese Laymon as the 17th Annual Anne Braden Memorial Lecturer. Kiese Laymon is a Black southern writer from Jackson, Mississippi. Laymon is the Libbie Shearn Moody Professor of English and Creative Writing at Rice University. He is the author of Long Division, which won the 2022 NAACP Image Award for fiction, and the essay collection, How to Slowly Kill Yourself and Others in America, named a notable book of 2021 by the New York Times critics. Laymon's bestselling memoir, Heavy: An American Memoir, won the Andrew Carnegie Medal for Excellence in Nonfiction, the Christopher Isherwood Prize for Autobiographical Prose, the Barnes and Noble Discovery Award, the Austen Riggs Erikson Prize for Excellence in Mental Health Media, and was named one of the 50 Best Memoirs of the Past 50 Years by The New York Times.

He is also a 2022 MacArthur Fellow and the founder of "The Catherine Coleman Literary Arts and Justice Initiative," a program based out of the Margaret Walker Center at Jackson State University, aimed at aiding young people in Jackson get more comfortable reading, writing, revising and sharing on their on their own terms, in their own communities.

WHAT'S NEW IN SOCIAL JUSTICE RESEARCH?

History of Policing in Louisville

Research Team: Drs. Felicia Jamison, Siddhant Issar, Catherine Fosl, and student assistants

This research project will produce a 2024 report that chronicles policing in Louisville, 1778-present. The team is reviewing relevant archival sources, interviews, and media coverage to examine both historical and present-day institutional harms connected to policing locally. Their work is part of Louisville Metro's Truth and Transformation Initiative, a partnership between Metro Office of Equity and the National Network for Safe Communities. This project will receive partial funding from the Anne Braden Institute.

VOTE IS SACRED

The Vote is Sacred (VIS) is a national, nonpartisan civic engagement initiative created by Interfaith America that seeks to inform and equip citizens with the practical steps needed to secure the right to vote for all Americans. Essentially, this initiative aims to spark a national conversation about how voting is rooted in diverse faith traditions and practical ways those traditions can come together to protect our democracy.

As a second-year recipient of the ViS grant, we will be focusing on the themes of voter registration, Kentucky voting rights restoration, and interfaith cooperation. Our partners this year include Kentuckians for the Commonwealth (KFTC), UofL Vote Everywhere, and the Cultural and Equity Center's Black and Multiracial Initiatives.

Our upcoming National Voter Education Week is from October 2-6. The week will include a two-part film screening of Move When the Spirit Says Move: The Legacy of Dorothy Cotton Foreman featuring speakers Savvy Shabazz (PAS Alumnus) and Taylor Martin (KFTC).


HIGHLIGHTS FROM Vis 22-23

FACULTY AFFILIATE SPOTLIGHT

Lauren Freeman is a Professor of Philosophy at the University of Louisville; an affiliated member of the Department of Women's, Gender, and Sexuality Studies; and Director of the M.A. in Applied Philosophy/Health Care Ethics. Dr. Freeman conducts impact driven, bioethical, and medical research that aims to understand how members of marginalized groups are oppressed in both obvious and subtle ways within the context of science, medicine, health, and healthcare. Dr. Freeman has been invited to lecture and give workshops to healthcare, legal, healthcare risk management, and medical audit organizations across the United States, Canada, and in the United Kingdom on how to implement more just, compassionate, equitable healthcare for marginalized people. She is passionate about mentoring undergraduate and graduate students from underrepresented groups. Her book, Microaggressions in Medicine, is forthcoming with Oxford University Press in 2024.



Siddhant Issar is an Assistant Professor of Political Science at the University of Louisville. His research and teaching interests include modern and contemporary political theory, particularly Black, Indigenous, and anti-colonial thought, the Black Lives Matter movement, and the transnational politics of race, empire, and inequality. His work has appeared in journals such as Contemporary Political Theory, Race & Class, and Political Theory. In 2022, Issar was named a co-winner of the American Political Science Association's Leo Strauss Award, presented annually for the best dissertation in political philosophy. At present, he is working on a book manuscript, titled Theorizing Racial Capitalism in the Era of Black Lives Matter. Before joining UofL, Issar was a Rising Scholar postdoctoral fellow in the Department of Politics at the University of Virginia.



Emmanuel Kumah Graduate Assistant PhD, Pan African Studies

Emmanuel Kumah is a Ph.D. student in Pan-African Studies and an M.A. student in Sociology. He earned an M.A. in Religious Studies with a concentration in Culture and Politics from Missouri State University, Springfield, Mo. His current research interests are in Pentecostalism, the Black Church, immigration, ethnicity, new religious movements, and popular culture in Ghana.
