State of Metropolitan Housing Report 2013



Since 2006, CEPM has produced the State of Metropolitan Housing Report for the **Metropolitan Housing Coalition**. This year's report focused on the state of the rental market and the demographics of renters in the Louisville MSA. Findings include:

- --Approximately 36 percent of the Jefferson County population lives in residential rental housing units. This represents a dramatic one-year increase of 5 percent (33 percent in 2011) and the highest rate of persons in rental units since 2000.
- --The 2012 homeownership rate for the Louisville MSA was 63 percent, up slightly from 2011, but still 7 percent lower than when MHC began tracking the figure in the 2003 State of Metropolitan Housing Report.
- --The living wage in Louisville for an adult with one child is \$17.27; for an adult with two children it is \$21.59. Though these wages are sufficient to afford a two- or three-bedroom rental unit, the typical hourly

rate for 68 percent of all workers is below \$17.27 and only 20 percent of the employed workforce makes more than \$21.59.

EPA's Brownfields Assessment, Revolving Loan Fund and Cleanup Grant

The EPA is accepting proposal submissions for its **Brownfields Assessment, Revolving Loan Fund and Cleanup Grant**. This grant is intended to address sites contaminated by petroleum and hazardous substances, pollutants, or contaminants. These grants include:

Brownfields Assessment Grants (each funded up to \$200,000 over three years; coalitions are funded up to \$600,000 over three years),

Brownfields Revolving Loan Fund (RLF) Grants (each funded up to \$1,000,000 over five years) and Brownfields Cleanup Grants (each funded up to \$200,000 over three years). Follow this **link** to learn more or apply. Proposal submissions are due January 22, 2014.

EPA 2014 National Training Conference on the Toxics Release Inventory (TRI) and Environmental Conditions in Communities

The United States Environmental Protection Agency (US EPA) and Dillard University's Deep South Center for Environmental Justice (DSCEJ) are the co-sponsors of the 2014 National Training Conference on the Toxics Release Inventory (TRI) and Environmental Conditions in Communities. The Training Conference will be held May 7-9, 2014, in Arlington, Virginia at the Hilton Crystal City.

The Training Conference serves as the main public outreach and training event for US EPA's flagship community right-to-know regulatory program – the Toxics Release Inventory, the goal of which is to provide communities with information about toxic chemical releases and waste management activities. The conference augments existing online training provided throughout the year and fosters the exchange of information between US EPA, localities, states, tribes, federal agencies, industry, community groups, researchers, and nongovernmental organizations.
