EPA Announces Solicitation of Applications for \$1 Million in Environmental Justice Grants

The U.S. Environmental Protection Agency (EPA) announced that the agency is seeking applicants for \$1 million in environmental justice small grants expected to be awarded in 2012. The EPA's environmental justice efforts aim to ensure equal environmental and health protections for all Americans, regardless of race or socioeconomic status. The 2012 grant solicitation is now open and will close on Feb. 29, 2012.

Urban Waters Small Grants

The EPA expects to award between \$1.8 to \$3.8 million in grants for projects across the country that will contribute to improved water quality and community revitalization. The goal of these Urban Waters Small Grants is to fund research, studies, training and demonstration projects that will advance the restoration of urban waters by improving water quality through activities that also support community revitalization and other local priorities. EPA Issues First National Standards for Mercury Pollution from Power Plants



WASHINGTON – The U.S. Environmental Protection Agency (EPA) has issued the Mercury and Air Toxics Standards, the first national standards to protect American families from power plant emissions of mercury and toxic air pollution like arsenic, acid gas, nickel, selenium, and cyanide. The standards will slash emissions of these dangerous pollutants by relying on widely available, proven pollution controls that are already in use at more than half of the nation's coal-fired power plants.

EPA estimates that the new safeguards will prevent as many as 11,000 premature deaths and 4,700 heart attacks a year. The standards will also help America's children grow up healthier – preventing 130,000 cases of childhood asthma symptoms and about 6,300 fewer cases of acute bronchitis among children each year. Ecosummit 2012 in Columbus, OH



EcoSummit 2012 will bring together the world's most respected minds in ecological science to discuss restoring the planet's ecosystems. Come hear Nobel Prize laureate Elinor Ostrom, Pulitzer Prize winners E.O. Wilson and Jared Diamond, Kyoto Prize winner Simon Levin, Stockholm Water Prize laureates Sven Jørgensen and William Mitsch, and many others in the first conference ever linking the Ecological Society of America (ESA), The International Association for Ecology (INTECOL) and the Society for Ecological Restoration International (SER).

70 symposia and 11 workshops with almost 600 participants from over 55 countries have been accepted for the EcoSummit 2012 Program. The symposia and workshops cover a wide variety of ecological topics, including ecological restoration, ecosystem services, climate change issues, and lake, wetland, and river management and will be presented over the entire week of the conference in parallel sessions.

Black Bear Sightings Increase in Alabama



Black bear sightings in Alabama outside of their primary range of Mobile and Washington counties have increased in 2011. While hunted in other parts of the country, black bears are a protected species in Alabama and no hunting season is established for them. During the spring and summer of 2011, bears were reported in several locations throughout Alabama. A male bear was tranquilized in Jefferson County and relocated to suitable bear habitat in another part of the state. Another bear was seen on multiple occasions as it traveled across north Alabama toward Mississippi. Several other bear

sightings occurred in Macon and Chambers counties. Recently an adult bear has been the subject in several game camera images taken in Barbour County.
