Shawn, I had previously reviewed the results of the SI for this site, which was completed in February 2011, and spoke to Cheryl about this. At that time, I did note that the Removal Action Levels (RALs) for pesticide constituents were exceeded in at least 2 locations onsite. Since START was involved with the collection of that data, we can use that in our evaluation of the site, The release of hazardous substances to the environment is documented. We will probably need to gather some additional data to better define the extent of contamination, particularly if there is a concern about off-site areas.

Donna, we need to get together to discuss to see where this site is headed within the remedial program. In the meantime, do we still have access to the site?
