Re: Notice of Federal Interest and Request for Access and Securing of Site located at 1391 Dixie Highway, Louisville, Kentucky 40210

Mr. Brooks:

The purpose of this letter is to inform you that a release or threatened release of hazardous substances, pollutants or contaminants for which your client, Louisville Industrial Park LLC, may be responsible, has occurred or threatens to occur at the following location: 1391 Dixie Hwy, Louisville, Kentucky 40210.

The U.S. Environmental Protection Agency has an interest in this incident and may conclude that a removal action is necessary to clean up or contain the release. A removal action is an action that may be necessary to monitor, assess and evaluate the release or threat of release of hazardous substances, pollutants or contaminants and includes physical removal and disposal of hazardous substances, pollutants or contaminants. Pursuant to the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA), the EPA is authorized to address this release or threatened release.

The EPA believes a removal action is likely necessary, and will request that liable parties conduct the removal action if the EPA determines that the liable parties will conduct such action promptly and properly. Liable parties under Section 107 of CERCLA generally include the current owner or operator of the property, anyone who owned or operated at the property when hazardous substances were disposed, generators of hazardous substances disposed of at the Site, and transporters of hazardous substances.

EPA's On Scene Coordinator shall determine the adequacy of the removal action performed by liable parties and shall provide guidance and oversight of such action. The On-Scene Coordinator for this incident is Art Smith. Please contact Mr. Smith at 502-905-7559 before taking any action to address this release or threatened release.


If liable parties decline the opportunity to take appropriate action or if the EPA determines that liable parties cannot perform the removal action promptly and properly, the EPA may conduct the removal action itself. If the EPA conducts the removal action, liable parties will be held financially responsible for costs incurred by the EPA as set forth in Section 107 of CERCLA.

Because of the release or threatened release and risk of exposure, the EPA requires that the Site be properly secured. As you may know, portions of the fence surrounding the property are compromised, and the gate is in disrepair, allowing for the continued trespass of the property. The EPA requests that your clients, the property owners, exercise due care and repair the fence and gate at the property by September 6, 2011.
