

A. INTRODUCTION

This report presents information on the West Broadway Corridor. Existing conditions in the corridor are presented and changes proposed as part of two neighborhood plans are summarized. For purposes of this report, the West Broadway Corridor runs from Ninth Street west to the Shawnee Expressway (Interstate 264) and includes an area roughly one block north and south of Broadway. Elliott Avenue and Magazine Street approximate the Corridor's boundary on the north, Maple Street generally constitutes its southern boundary.

Most of this report's data is presented in map form; the maps are found in the Attachments section. The maps were prepared using data from field surveys and from neighborhood plans (verified in field checks). All field work was conducted during September of 1982. The Existing Zoning map reflects conditions as of September, 1982. Data on property ownership reflects the current records of the Jefferson County Property Valuation Administration.

B. EXISTING CONDITIONS

1. Land Use

The Existing Land Use map, page 9 in the Attachments section shows the current state of development in the West Broadway Corridor. The 18-category land use classification system is explained on the facing page. The Corridor is characterized by mixed land uses: residential, commercial, industrial and institutional. The following land use patterns can be identified. Development facing Broadway between 9th and 15th Streets is non-residential in character. West of 15th Street, single-family and multi-family structures occur, in conjunction with commercial and industrial uses. Industrial development is concentrated in three areas: a corridor between 28th and 31st Streets, the Dixie Highway and Broadway area, and east of 15th Street (Station Park). Industrial use is more extensive south of Broadway than to the north. The largest vacant sites in the corridor are located at 28th and Broadway, and at Dixie Highway and Broadway. Residential development is the predominant use in the areas that do not face Broadway, although there are several industries on interior block faces south of Broadway.

2. Condition of Structures

The map of structural conditions appears on page 11, followed by the definitions of the categories used. Structural conditions were rated by a windshield survey, no interior inspection was conducted. This technique does not reflect conditions of mechanical systems or structural defects that are not evident from the exterior. The windshield survey showed residential structures to be in worse condition than non-residential structures. Housing conditions in the area west of 21st Street are better than those in the eastern half of the Corridor. The results of the survey are as follows:

3. Zoning

The Existing Zoning Map, page 12, indicate the current potential for development in the West Broadway Corridor. The Corridor is zoned for residential, commercial and industrial use, with the M-2, M-3, C-2 and R-6 zones being the most extensive classifications. Sites facing Broadway are all zoned for commercial or industrial use, with the exception of the area west of 31st Street. Industrial zoning is more common south of Broadway, and extends farther into the adjoining neighborhood than it does on the north side of Broadway. The late requirements and uses permitted in the zoning districts that occur in the Corridor are summarized beginning on page 15.

4. Property Ownership

Current information on property ownership in the West Broadway Corridor is the final part of the Attachment, beginning on page 30. The 18 tax-blocks in the corridor are shown individually, followed by information on each parcel (owner, owner's address, parcel address, current land use, condition of structure, zoning).

C. RELATIONSHIP TO NEIGHBORHOOD PLANS

The West Broadway Corridor is situated inside the study areas of three neighborhood plans: Russell, California and Parkland. The Neighborhood Plan Ordinance (Ordinance 22, Series 1980, City of Louisville) establishes standards for the planning process and content of these plans. The Ordinance also provides for adoption of neighborhood plans by the Board of Aldermen. Upon adoption, the neighborhood plan will guide public and private decision making; in particular, budgets, areawide rezonings and zoning change requests by individuals should be consistent with the plan.

The neighborhood plans affecting the West Broadway Corridor have not yet been approved by the Board of Aldermen. The Russell Neighborhood Plan was prepared by the Russell Neighborhood Commercial Revitalization and Development Corporation with the assistance of Schimpeler-Corradino Associates. The first draft was issued in October 1980, and a revised draft is being submitted to public agencies for their review in September of 1982. The final sign-off by the Community Development Cabinet and approval by the Board of Aldermen are still needed. The California Neighborhood Plan was prepared by the Steering Committee of the California Task Force, in conjunction with the Planning Commission staff. A first draft of the plan has been reviewed by area residents and public agencies. The plan has been revised and adopted by the California Task Force. Final review by the Community Development Cabinet and approval by the Aldermen are still pending. A plan for the Parkland neighborhood will be developed by the Planning Commission under contract to the Community Development Cabinet in 1982-83.

Neighborhood plans are mandated by Ordinance 22 to contain land use and transportation elements. The land use recommendations for the West Broadway Corridor developed in the Russell and California plans are presented on the Recommended Future Land Use map, page 13. Zoning changes to

help implement the future land use pattern are shown on the Recommended Future Zoning map, page 14.

1. Future Land Use

The California portion of the West Broadway Corridor, south of Broadway and east of 28th Street, is divided into three areas for land use recommendations. The large vacant site between 26th and 28th Streets is proposed for industrial use, to permit the expansion of existing firms. If not needed by existing firms, the site is recommended for a regional shopping center, or as a third choice, high density housing. The California Plan recommends mixed uses -- housing and industrial development -- in the area between 15th and 26th Streets. Retention of the major industries and their expansion are supported, as is improvement of the area's housing stock. New commercial establishments should be located in existing non-residential structures, and only limited expansion of existing commercial uses is supported in the mixed use area. East of 15th Street, the California Plan supports the full development of the Station Park industrial project.

The Russell Neighborhood Plan recommends a future land use pattern for the area north of Broadway. A combination of residential, general commercial, neighborhood commercial, industrial and institutional uses is recommended for this portion of the West Broadway Corridor. Neighborhood commercial uses would be concentrated in nodes currently providing this type of shopping: 13th, 28th, and 31st Streets at Broadway. General commercial areas along Broadway are appropriate for franchise businesses and auto-oriented uses that benefit from the corridor's high traffic volumes. Industry should be limited to the area between 28th and 31st Streets and the corridor along 15th Street. Existing residential concentrations in the Broadway corridor should be preserved. Additional recreational facilities proposed in the Russell Plan include a playground at 16th and Magazine Streets, and a park in conjunction with

housing rehabilitation in the block between Magazine, 22nd, Broadway and 23rd Streets.

2. Future Zoning Pattern

The recommended Future Zoning map shows areas in the West Broadway areas to be rezoned and areas where existing zoning should be retained. The rezoning recommendations in the Russell area (north of Broadway) require some explanation. The Russell plan indicates areas to be rezoned for residential use and recommends an average residential density of 12 dwelling units per acre for the neighborhood as a whole, but does not recommend specific zoning classifications for each area. This approach was taken to allow greater flexibility in the rehabilitation and redevelopment of residential areas. Specific zoning districts should be assigned once the redevelopment patterns for these areas are determined. The R-5, R-5A, and R-6 zoning districts most closely approximate the types and intensity of residential use envisioned in the Russell Plan, although higher density zones may be acceptable in some areas.

In the California area (south of Broadway), three areas are recommended for rezoning from C-2 Commercial to the R-6 Apartment District. These changes promote the land use recommendations for the mixed-use area, by supporting existing residential uses and restricting the potential for new commercial development.



EXISTING LAND USE




Definitions of Structural Classifications


Residential Structures

- a. SOUND Structure is sound in all respects -- in an excellent state of repair.
- b. SOUND STRUCTURE MINOR REPAIR Structure is sound -- in need of only limited minor repairs, has no defects or only slight defects which are normally corrected during the course of regular maintenance (Such as: lack of paint; slight damage to porch or steps; small cracks in wall or chimney; broken gutters or downspouts; slight wear on floor or door sills).
- c. SOUND STRUCTURE MAJOR REPAIR Structure is deteriorating -- in need of extensive minor repairs, more repairs than would be provided during the course of regular maintenance; one or more defects and/or deficiencies or an intermediate nature which may or may not be economically feasible to undertake as a whole (Such as: shaky or unsafe porch steps; holes, open cracks or missing material over a small area of the walls or roof; rotting window sills or frames), but not containing an apparent number of defects and/or deficiencies to justify clearance on just the condition of the structure. A general or major rehabilitation job is required for these units.
- d. DETERIORATED STRUCTURE MAJOR REPAIR Structure is deteriorated -- it contains a combination of defects and/or deficiencies in structural and non-structural elements of total significance and to an extent possibly requiring clearance. Such defects and deficiencies being to the extent that the structure will not meet criteria for the C. "Sound Structure Major Repair" classification. These units are questionable for rehabilitation because of the cost factor.
- e. DILAPIDATED BEYOND REPAIR Structure is dilapidated -- has at least two major structural defects (Such as holes, open cracks or missing materials over a large area of walls, roof or other parts of the structure; sagging floor, walls or roof; damage by storm or fire) to the degree requiring clearance.


Non-Residential Structures


- A. STANDARD Structure is apparently sound in all respects; structure is in need of only limited minor repairs which are normally made during the course of regular maintenance, such as painting, clean-up of yard and/or structure, repair of screens, or repair of gutters and downspouts.
- B. DEPRECIATING Structure is deteriorating and in need of extensive minor repairs -- more repairs than could be provided during the course of regular maintenance, such as shaky or unsafe porch steps, repair or siding, minor roof or chimney repair, or repair or removal of accessory buildings -- but not containing a sufficient number of defects and/or deficiencies to justify clearance solely because of the structure's condition.
- C. SUBSTANDARD Structure is dilapidated and contains a combination of structural defects and/or deficiencies requiring major repairs (such as sagging floors, walls, or roof, open cracks or missing materials over a large area, major problems with roof or porch) to a degree requiring clearance.








Areas recommended for zoning change

R-1 RESIDENTIAL DISTRICT

The following provisions shall apply in the R-1 Residential District unless otherwise provided in these regulations:

A. USES PERMITTED:

Agricultural uses

Churches, and parish halls, temples, convents, and monasteries

Colleges, schools and institutions of learning (except trade, business, or industrial schools), not for profit

Community residences

Country clubs

Family care home (mini home)

Golf courses, except miniature courses, driving ranges, or privately owned golf courses operated for commercial purposes

Home occupations

Libraries, museums, historical buildings and grounds, arboretums, aquariums, and art galleries, not for profit

Parks, playgrounds, and community centers, not for profit

Single family dwellings

Temporary buildings, the uses of which are incidental to construction operations being conducted on the same or adjoining lot or tract, and which shall be removed upon completion or abandonment of such construction, or upon the expiration of a period of two years from the time of erection of such temporary buildings, whichever is sooner

Towers (Radio/TV receiving or transmitting) for non-commercial use, in accordance with Federal Communications Commission and/or Federal Aviation Agency requirements

Accessory buildings or uses

R-6 APARTMENT DISTRICT

The following provisions shall apply in the R-6 Apartment District unless otherwise provided in these regulations.

A. USES PERMITTED:

All uses permitted in the R-1 Residential District

Group houses

Dwellings, Two Family

Multiple-family dwellings

Row houses as provided for in Section III. (RHD)

R-7 APARTMENT DISTRICT

The following provisions shall apply in the R-7 Apartment District unless otherwise provided in these regulations:

A. USES PERMITTED:

All uses permitted in the R-6 Apartment District
Boarding and lodging houses
Fraternities, sororities, clubs, and lodges, excluding those
the chief activity of which is a service customarily
carried on as a business

R-9 APARTMENT DISTRICT

An apartment and office building district allowing businesses normally incidental to the primary uses located within the same building, and not allowing such incidental business uses to be accessible and evident from the outside of the building.

The following provisions shall apply in the R-9 Apartment District unless otherwise provided in these regulations:

A. USES PERMITTED:

All uses permitted in the R-8 Apartment District
Apartment hotels, and office buildings, including businesses customarily incidental to such uses conducted for the convenience of the occupants and provided all entrances, designs, signs and show windows for such uses shall not be evident from the outside of the building.

C-1 COMMERCIAL DISTRICT

The following provisions shall apply in the C-1 Commercial District unless otherwise provided in these regulations:

A. USES PERMITTED:

All uses permitted in the R-7 Apartment District
Automobile parking areas, public and private
Automobile service stations
Bakeries, retail (all products produced to be sold on the premises only)
Banks
Barber shops
Beauty shops
Beer Depots where alcoholic beverages are not consumed on the premises
Bicycle sales and service
Bowling alleys, provided the building is sound proof
Book stores
Business schools
Confectionery or candy stores, retail (all products produced to be sold on the premises only)
Community buildings
Day Care Centers, Day Nurseries, Nursery schools and Kindergartens
Department stores
Dressmaking or millinery shops
Drug stores
Dry cleaning, dyeing, pressing, and laundry; distributing stations or retail business where no cleaning, dyeing, pressing or laundry is done for other distributing stations or cleaning establishments
Dry goods and notion stores

the premises, and provided that not more than fifty (50)
percent of the floor area of the building is used in the
manufacture, processing, or treatment of products, and that
such operations or products are not objectionable due to
noise, odor, dust, smoke, vibration, or other similar causes

Auction sales, except animals and tobacco
Automobile repair garages
Automobile sales agencies
Automobile washing stations
Bookbinding
Bowling Alleys
Building materials, storage and sales provided all operations are totally enclosed in a building
Cleaning, pressing, and dyeing establishments using non-flammable and non-explosive cleaning fluid

Engraving, watchmaking, and jewelry manufacturing, where products are sold on premises
Equipment rental, where all activities are within a building
Furniture, storage
Garages, public
Governmental buildings, including armories, storage, maintenance and repair facilities

C-3 COMMERCIAL DISTRICT

The C-3 Commercial zone is intended as a specialized district primarily for the Central Business District (CBD) (bounded by the Ohio River on the north, York Street on the south, the North-South Expressway (I-65) on the east and Roy Wilkins Boulevard on the west) for the location of high density/intensity commercial and residential developments recognizing the CBD as the focal point of the business and commercial area and transportation facilities in Jefferson County, Kentucky.

A. USES PERMITTED:

All uses permitted in the R-9 Apartment and C-2 Commercial Districts

M-1 INDUSTRIAL DISTRICT

The following provisions shall apply in the M-1 Industrial District unless otherwise provided in these regulations:

A. USES PERMITTED:

Dwellings only in connection with bona fide agricultural operations, or as living quarters for bona fide caretakers and/or for watchmen and their families

Uses, manufacture, processing, treatment, or storage of the following:

Adhesives, excluding manufacturing of basic components

Agricultural uses

Awnings, metal

Beverage (non-alcoholic) manufacture

Beverage, blending and bottling

Blacksmith

Bookbinding

Broom and brush

Button manufacture, except button blanks from shell

Carbon paper and ink ribbons

Carpenter, cabinet making, and pattern shops

Carting and light local deliveries

Chemicals (packaging only)

Clay products of handicraft nature including ceramics, pottery, tile (glazed), or similar products

Cleaning and dyeing of garments, hats and rugs

M-1 INDUSTRIAL DISTRICT (cont.)
