➤ 2016-17 Parking Changes

- o Parking Lot south of Dental School
 - Parking lot closed on July 19th due to the construction of the Pediatric Ambulatory Care building
 - 22 handicap spaces were relocated from the parking lot to the Chestnut Street Garage
 - Ricardo Caicedo commented that due to the limited communication to patients and lack of wayfinding signs that some patients have canceled or not shown for their scheduled appointments. Vehicular wayfinding signs have recently been added near the construction site and this has improved conditions.

o University Pointe

- University Pointe opened on August 19th. University Pointe has 532 beds.
- University Pointe residents qualify to purchase Yellow permits.
- The Yellow lot at the end of Cardinal Blvd provides 95% of the residential parking for the west side of campus.
- During the 2015-16 academic year utilization reports showed approximately 250-300 available spaces.
- During the current academic year all residential spaces were utilized and some residents were parking in employee spaces. Parking & Transportation Services worked with SGA and adjustments were made

- to the number of Blue and Green spaces within the lot to accommodate all yellow permit holders. Current utilizations show 30-40 available spaces daily.
- Lauren Greenwell asked about the parking lot located on the south side of University Pointe. There is currently no parking signs present.
 Parking & Transportation Services is working with the Foundation and PARC to determine who has ownership of this lot.
- o Papa John's Cardinal Stadium
 - Thornton Academic Center
 - Thornton Academic Center opened at the beginning of the 2016-17 academic year. Parking is located next to the Thornton Academic Center.
 - A windshield parking permit was provided to those students attending the Center.
 - No feedback was given.
 - Green Permit Qualification Change
 - Due to pending construction of the Belknap Research Park the Green parking lot on 3rd Street is scheduled to close at the end of the fall semester. University Administration made the decision that all commuting Undergraduate students would no longer qualify to purchase Green permits and would need to park at Papa John's Cardinal Stadium.
 - No feedback was given.
- TARC Service
 - Route #94
 - 4 additional hours of service (2:30pm-6:30pm) were added to route #94 beginning with the academic year.
 - Lauren Greenwell said that she would solicit feedback from several student groups.
 - Route #98
 - 5 hours of service (8:30am-1:30pm) began with the beginning of the academic year. Route #98 provides express service along Floyd Street. Ridership has been minimal and since funding has not been identified for this route, the route will most likely be discontinued at the end of the semester unless ridership increases
 - No feedback was given.

- Tammy Lawson expressed concerns about traffic flow during home football games and where complaints should be given.
- Gary Becker checked with University Police and all traffic complaints should be directed to Joe Seelye from Metro Police.
