# Bachelor of Arts in Art History Request for SACSCOC Program Closure Approval

The Bachelor of Arts (BA) in Art History is a 121-credit hour undergraduate level degree program housed in the Department of Art and Design in the College of Arts and Sciences (A&S). During the program review process, the Kentucky Council for Postsecondary Education identified the degree program for closure due to low and declining enrollment, low degree conferrals, and low student market demand.

After careful review and consideration, the Art and Design faculty voted to approve a proposal submitted by Professor Mary Carothers, Department Chair, to close the BA in Art History degree program effective summer 2022. The A&S Curriculum Committee and A&S Faculty Assembly both approved the recommendation submitted by the Art and Design faculty. The Art and Design faculty plan to convert the BA in Art History degree program to an Art History track within the BA in Art degree program. The faculty believe this will provide the same educational benefits and curricular rigor to students while best utilizing the pedagogical resources within the unit to fulfill the unit's and institution's strategic plans.

#### **Bachelor of Arts in Art History Enrollment**

The number of students enrolled in the BA in Art History has remained low.

#### I. Students:

As of fall 2021, there are 15 students enrolled in the BA in Art History degree program. Four of those students will complete their degree requirements and graduate in spring 2022. One student is a second-degree senior who has completed the art history requirements and has 15 hours remaining outside the department. The remaining ten students have outstanding credit-hour requirements for degree completion ranging from 21 to 112 hours. All ten students are expected to complete the degree program and graduate by spring 2026. If, for any reason, a student would be unable to complete the program within the 5-year teach-out period, they would be able to transition into the proposed BA in Art with a track in Art History degree program that is being established. Additionally, the courses currently being offered as part of the degree requirements for the BA in Art History degree program.

#### II. Notification of Faculty & Staff

The proposed program closure has no impact on faculty. The Department of Art and Design will begin to offer a BA in Art with a track in Art History in summer 2022. All Art History and Art faculty will maintain full instructional loads. There will be no impact on departmental staff.

#### III. Communication Plan

The Department of Art and Design faculty in both Art and Art History were notified of the department's intent to recommend program closure, and it was approved by the faculty. The department chair will notify faculty via e-mail when the substantive change is submitted to SACSCOC in anticipation of the closure being approved. Advisers will be notified of the change, and students currently enrolled in the BA in Art History program will be notified directly via email by the program chair of the program closure and their options to complete the degree requirements. The completion pathway provides students ways to complete the degree based on the official UofL Academic Catalog at the time of their enrollment through spring 2022. Current students will have the choice to stay in the BA in Art History and complete all requirements by spring 2026 or transition to the BA in Art with a track in Art History if they would prefer to obtain that academic degree.

#### IV. Effective Date

Students will no longer be admitted to the BA in Art History beginning in the summer 2022 term. The BA in Art with a track in Art History will be available for the summer 2022 term.
