REPORT: Student Government – Fuller

- Tenure Policy Research: Submission deadline October 27, 2017
- Faculty Senate XC response to closed presidential search Senate Vice Chair, Krista Wallace-Boaz thanked the committee for its help on developing the letter to the Board of Trustees.
- **Tuition Increase** The committee discussed tuition and the effects a state budget cut will have to the University. The state legislature does not announce budget cuts until late spring, but tuition is set before the cuts are known. Concerns were raised about the affect cuts will have on the quality of education and that cuts will require a tuition increase, putting the financial burden on the backs of students.
- Forum Discussion Input Vice Chair Wallace-Boaz began the discussion by asking for ideas for the forum discussions. The committee had issues with the chart that was provided, stating that the listed points were meaningless without context.
- **2017 RIFs** More current information is needed for a discussion.

- **CFO/COO Searches** This is the position that Harlan Sands held. It has been split into two positions.
 - Chief Operating Officer This is an ongoing search for the position currently held by Lee Smith. The search committee is chaired by John Elliott, AVP-HR. There is no search firm.
 - Chief Financial Officer The search for this position began last spring. This committee met with the finalist.

- Academic Programs Committee (APC) Ng
 - This committee met last week to discuss proposals from Public Health and College of Business. The proposed suspension of the Paralegal Program was also discussed.
