## **CALL TO ORDER**

## ACTION ITEM: Approval of the November Minutes - Mueller

The November meeting minutes were unanimously approved as distributed.

## **REPORT: University Provost - Bradley**

Dr. Bradley reported on the following topics.

**Strategic Plan** – Provost Bradley discussed the ongoing strategic planning process, emphasizing the need for a new plan by 2026. The current plan, approved by the Board of Trustees in 2023, is a three-year plan, and the new plan will be developed in 2025 to be ready for board approval in 2026. He also highlighted successes in retention improvements, the development of a faculty dashboard for student outcomes, and the introduction of Spanish language campus tours and admissions materials.

**Searches** – Dr. Bradley provided updates on the decanal searches for the College of Business and the School of Dentistry. The College of Business search is in the active recruitment phase, with a position profile finalized and posted. The School of Dentistry search committee will be charged in January 2025.

**Enrollment** – Provost Bradley highlighted positive trends in enrollment, particularly in Arts and Sciences. Winter enrollment is up by 2%, and spring enrollment is looking strong, with a significant increase in undergraduate enrollment.

**Faculty Hires** - Provost Bradley presented data on faculty turnover and hiring, noting that the turnover rate is improving. He emphasized the importance of tracking these metrics to monitor climate and compensation efforts.

- **Turnover Data:** Provost Bradley presented data on faculty turnover, noting that the turnover rate for faculty was 7.9% in 2021-2022 and increased to about 9% in 2022-2023. The staff turnover rate was 13.7% in 2021-2022 and increased to about 15% in 2022-2023.
- Improving Trends: Mr. Bob Goldstein confirmed that the most recent data shows continued improvement in turnover rates across most metrics, which is attributed to efforts to improve climate and compensation.
- Hiring Data: Provost Bradley provided data on faculty hiring, noting that from July 1 to November 29, there were 155 hires, with the large majority being term faculty in the School of Medicine.
- **Monitoring Metrics:** Provost Bradley emphasized the importance of tracking turnover and hiring metrics to monitor the impact of climate and compensation efforts. One goal is to have a dashboard to provide real-time data and trends.

### **REPORT: Student Government - Waddle**

Ms. Waddle provided updates on resolutions passed, changes in advising, and the implementation of extended library hours.

## **REPORT: Faculty Senate Chair - Mueller**

Dr. Mueller reported on the following topics.

Asset Preservation Projects – All the project currently underway are alon schedule.

**Administrative Searches** – The search for the Executive Vice President for Finance and Chief Financial Officer is underway. Interviews with the finalists for Vice President for Philanthropy and Alumni Engagement are taking place virtually this week with the goal to have four on campus interviews soon afterwards.

## **INFORMATION ITEM: Program GPA Calculation - DePuy**

Senior Vice Provost, Dr. Gail Depuy explained this effort to standardize program GPA calculation across units so it can be automated within all systems. It will also help students to know how their program GPA is calculated as they move through their course work towards graduation. This policy has been through several iterations and will be implemented for students graduating in summer 2025.

# **REPORT: Faculty Grievance Officer - Trucios-Haynes**

Faculty Grievance Officer and Professor Enid Trucios-Haynes presented the Annual Faculty Grievance Officer report (linked above), highlighting the low number of grievances filed and the importance of consultations. She explained the grievance process and the role of the Faculty Grievance Committee.

**Grievances Filed:** Professor Trucios-Haynes reported that only four grievances were filed last year, including one filed early in the 2024-2025 academic year. Two of the grievances were resolved within four to six months, while one remains outstanding.

**Consultations:** She emphasized the importance of consultations, noting that many consultations do not result in formal grievances. Consultations can last for months and help address issues informally. **Grievance Process:** She explained the grievance process, including the requirements for filing a Type 1 grievance, the role of the ombuds, and the steps involved in the grievance committee's review and resolution process.

**Faculty Grievance Committee:** The role of the Faculty Grievance Committee was explained, which includes determining jurisdiction, conducting hearings, and producing resolution plans with recommendations for remedies

# **ACTION ITEM: Southern Police Institute Center Proposal – Harris**

Senator Patrick Harris (Medicine) introduced Mr. Brad Campbell from the Southern Police Institute who presented the proposal (linked above) for the Southern Police Institute's training, research, and innovative Simulation Center (SPI TRAINS). The center aims to improve police training through realistic simulation and multidisciplinary collaboration between Criminal Justice, Theatre Arts, and the Southern Police Institute.

Training Programs: The center will offer innovative simulation training for justice professionals, including police officers, correctional officers, and attorneys. The training will involve actors portraying realistic scenarios to help officers practice and improve their skills.

After a brief discussion, the proposal was approved.

## ACTION ITEM: Graduate Certificate in Analytics for Engineering Decision-Making - Ng

Academic Programs Committee Chair, Dr. Chin Ng presented the proposal for the graduate certificate in Analytics for Engineering Decision Making. It was approved by the committee after addressing concerns regarding possible overlap with another program; the name was adjusted to avoid confusion. The proposal was approved.

## REPORT: Building Resilience In Campus Community (BRICC) Coalition - Hall/Uberti

Dr. Martin Hall (Kent) and Ms. Mary Beth Uberti (BRICC) discussed the services provided by the Building Resilience in Campus Community (BRICC) Coalition (a division of Campus Health), focusing on substance use prevention, harm reduction, and recovery support.
