Pres Schatzel pointed out that the budget proposed by the governor included only one capital project (not related to higher education) but added she was optimistic that the legislature will incorporate funding for a proposed building at HSC in an appropriations bill. UofL and other universities are also seeking additional funds for asset preservation in the budget. Dr. Schatzel also noted that performance funding was included in the governor's proposed budget.
