• Enrollment – Last month, it was reported that our budget was built on the expectation from the colleges that we would increase our enrollment by 200 students. We were actually down 194 students. That puts us at 394 less students than how we developed our budget. We are working with the colleges to keep students for the spring semester.

- Agreements We have 482 agreements and those are memorandums of understanding. They are
  material transfer agreements, data use agreements, all these types of things that demonstrate our
  broad engagement with other academic institutions, private sector companies, NGOs and so on.
- Licensing Agreements Menu In order to simplify the agreement process with companies, we've got a simple menu of three different options that that a company could choose from. It is a really important part of working with the university. We want to be a university that the state or business in the community they will know how to find the expertise that they need.
