UPDATE: University President – Schatzel

Pres Schatzel pointed out that the budget proposed by the governor included only one capital project (not related to higher education) but that she was optimistic that the legislature will incorporate funding for a proposed building at HSC in an appropriations bill. UofL and other universities are also seeking additional funds for asset preservation in the budget. I don't remember the details of what she said about performance funding except that it was included in the governor's proposed budget.
