University of Louisville - Higher Education Emergency Relief Fund (HEERF) Reporting - Emergency Financial Aid Grants to Students

HEERF III Reporting

- The University of Louisville signed and returned the 'Recipient's Funding Certification and Agreement' for the Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act on April 10th, 2020. An additional Certification and Agreement was not required for HEERF III. The university committed to provide no less than 50 percent of the funds received under Section 314(a)(1) to Emergency Financial Aid Grants to Students.
- 2. The Minimum Amount for Emergency Financial Aid Grants to Students for the University of Louisville is \$18,854,679.
- 3. As of June 1, 2022, \$18,854,679 has been distributed to students.
- 4. The University of Louisville estimates 20,319 students were eligible to receive Financial Aid Grants to Students under Section 314(a)(1) for academic year 2021 and over 13,000 have been confirmed as eligible to participate in programs under Section 484 in the Title IV of the Higher Education Act of 1965. For academic year 2022, UofL estimates 20,562 students were eligible to receive Financial Aid Grants to Students under Section 314(a)(1).
- 5. As of June 1, 2022, 15,716 unique students have received an Emergency Financial Aid Grant under Section 314(a)(1) of the CRRSA Act, totaling 27,496 total awards.
- 6. The University of Louisville's methodology for distributing funds (27,496 total awards):

Block Grants I. Processed for the Fall 2021 semester. Total Awarded = \$8,082,006.00 All Block Grants bypassed university accounts and were provided to students as a residual.

The university was able to prioritize need among undergraduates by relying on FAFSA data. For undergraduate students, awards ranged in amount from \$400 to \$1500 and were based on EFC (0-EFC students received \$1,500 grants, high-EFC students and students with No FAFSA received \$400, and there was a scale/grid for students between).

12,817 "block grants" have been awarded to continuing students at the University of Louisville. Undergraduate students were automatically evaluated for eligibility. Graduate students were asked to confirm a financial need via an invitation, Communication #1 below. All students receiving funds via block grant were provided a communication (see Communication #2 below).

Block Grants II. Processed for the Spring 2022 semester. Total Awarded = \$5,305,100.00 All Block Grants bypassed university accounts and were provided to students as a residual. The university was able to prioritize need among undergraduates by relying on FAFSA data. For undergraduate students, awards ranged in amount from \$400 to \$900 and were based on EFC (0-EFC students received \$900 grants, students with EFC up to \$28,000 received \$400, and there was a scale/grid for students between).

9,491 "block grants" have been awarded to continuing students at the University of Louisville. Undergraduate students were automatically evaluated for eligibility. Graduate students were asked to confirm a financial need via an invitation, Communication #1 below. All students receiving funds via block grant were provided a communication (see Communication #2 below).

Block Grants III. Processed for the 2021 Winter Session semester. Total Awarded = \$561,150.00

Students were given the opportunity to utilize HEERF III funding to support winter session courses. Students were invited to apply for funding (see Communication #3 below). The university was able to prioritize need among undergraduates by relying on FAFSA data. For undergraduate students, awards ranged in amount from \$550 to \$1000 and were based on EFC. Graduate students received a block grant of \$800.

734 "block grants" have been awarded to students at the University of Louisville for the 2021 winter session. All students receiving funds via block grant were provided a communication (see Communication #4 below). Students were given the option of receiving the funds via a residual/bypass the university account OR applying the funds to the university account. UofL used an electronic form to collect this information and see Communication #5 for an example communication.

Block Grants IV. Processed for the Spring 2022 semester. Total Awarded = \$1,264,300.00 All Block Grants bypassed university accounts and were provided to students as a residual.

A second block grant in Spring 2022 was available to support students with summer costs. The university was able to prioritize need among undergraduates by relying on FAFSA data. Awards ranged in amount from \$500 to \$550 (Pell eligible students received \$550 and all other students received \$500).

2,456 "block grants" have been awarded to continuing students at the University of Louisville. All students were asked to confirm a financial need via an invitation, Communication #1 below. All students receiving funds via block grant were provided a communication (see Communication #2 below).

Targeted HEERF Efforts. Total Awarded via targeted efforts = \$3,642,123.00

All Targeted HEERF Efforts allowed students to have the option of receiving the funds via a residual/bypass the university account OR apply to the university account. UofL used an electronic form to collect this information and see Communication #5 for an example communication.

Given the inherent nature of the individualized, targeted effort to identify students, student need was prioritized throughout these targeted mechanisms of distributing HEERF grants.

1,122 awards were made at the discretion of a University of Louisville Student Success Coordinator. Individual appointments were required to discuss a student's personal and financial situation. The professional staff recommended an award amount based on the student's unique situation.

Total Awarded via this targeted effort = \$2,535,117.12

3 students have been awarded to assist with math readiness in advance of their first year of college.

Total Awarded via this targeted effort = \$5,654.75

284 awards were made at the discretion of the Student Financial Aid Office and the Financial Aid Counseling Team. Students were reviewed as part of the Professional Judgement process and evaluated accordingly.

Total Awarded via this targeted effort = \$295,478.34

109 students have been awarded based on a successful appeal of institutional aid that was lost from the 20-21 aid year to the 21-22 aid year. Total Awarded via this targeted effort = \$471,000.00

480 students have been awarded at the discretion of the Graduate School. Students submitted an online application to be evaluated by professional staff within the Graduate School. Total Awarded via this targeted effort = \$334,872.79
