- Acceptable original documents for Proof of U.S. Citizenship: Original birth certificate, Passport, Passport
 Card, State Department documents (i.e., FS-240, FS-545, DS-1350), Naturalization Certificate, or Certificate of
 Citizenship (N-560 or N-561).
- Acceptable original documents for Proof of Eligible Non citizenship: Alien Registration Receipt Card (I551),
 proof of permanent residency status, or evidence from the Immigration and Naturalization Service that you are in
 the United States for other than a temporary purpose with the intention of becoming a citizen or permanent
 resident, or another document listed on the previous page.
