DOCUMENTATION OF CITIZENSHIP (Page 2 of Notary Version)

If the student is unable to appear in person at the University of Louisville to provide proof of U.S. citizenship or eligible non citizenship status, the student must present original documents to a Notary Public Official, along with a copy of a valid unexpired government-issued photo identification card (ID) bearing his/her portrait (or likeness).

- **Acceptable original documents for Proof of U.S. Citizenship:** Original birth certificate, Passport, Passport Card, State Department documents (i.e., FS-240, FS-545, DS-1350), Naturalization Certificate, or Certificate of Citizenship (N-560 or N-561), or another document listed on the previous page.
- **Acceptable original documents for Proof of Eligible Non citizenship:** Alien Registration Receipt Card (I551), proof of permanent residency status, or evidence from the Immigration and Naturalization Service that you are in the United States for other than a temporary purpose with the intention of becoming a citizen or permanent resident.
- **Valid unexpired government-issued photo ID:** A driver's license, other state-issued ID, or passport.
