

Your 2024-2025 Free Application for Federal Student Aid (FAFSA) has been selected for a review process called verification. The verification process requires the University of Louisville (UofL) Student Financial Aid Office (SFAO) to verify self-reported information from your FAFSA before finalizing your federal aid eligibility.

As part of the verification process, you must visit the University of Louisville Student Financial Aid office in person* to complete the **Verification of Identity and Statement of Educational Purpose** form.

Instructions:

1. **Print this form and bring it with you for step 3** (or we can print it for you when you visit the office).
2. **Complete the section below** (name, ID, and type of ID).
3. **You must appear in person*** at the **University of Louisville Student Financial Aid Office** to verify your identity by presenting an unexpired valid government-issued photo identification (ID).
 - a. Bring your original unexpired valid government issued ID with you to the office.
 - b. Please see the second page to determine which office location you should visit.
4. **You must sign in the presence of the institutional official*** the **Statement of Educational Purpose that will be provided to you when you visit the office.**
 - a. The statement will be provided to you when you visit the office.
 - b. A sample of the statement is provided on the second page of this form for your reference.

Such as, but not limited to, a driver's license, state-issued ID, passport, or passport card (military IDs are not acceptable).

Due Dates:

You must complete verification before your federal, state, and/or campus need-based financial aid⁽¹⁾ eligibility can be finalized and evaluated for disbursement to your student account.

- Verification must be completed by the priority due dates below to ensure your aid eligibility is evaluated prior to the start of the term in which you are enrolled. Your financial aid ⁽¹⁾ (if previously offered or disbursed) will be cancelled if your verification form and all required documents are not submitted by this date.
- Certain types of aid ⁽¹⁾ may not be available if verification is completed after the priority due date.
- Failure to submit the requested documentation by the deadline could result in the discontinuation of all application processing, including federal student loans ⁽³⁾.
- If you cannot meet the deadlines, please contact our office (the UofL Student Financial Aid Office).

⁽¹⁾ **Types of aid that may be awarded, cancelled, updated, and/or changed based on completion of the verification process:** Federal Pell, SEOG, IASG, and TEACH Grants, Federal Direct Loans, Federal Work-Study, state CAP Grant, and UofL Need-Based Grants. The verification process will determine if you are eligible for any of these types of aid.

⁽²⁾ If you received a specific deadline date by e-mail from our office, you must submit the verification form and required documents by that date or your financial aid ⁽¹⁾ will be cancelled.

⁽³⁾ **For Federal Pell Grant eligibility review only:** Verification must be completed by 9/5/2025, or 120 days after the last date of the student's 2024-2025 academic year enrollment, whichever is earlier.
