Dean Atlas indicated that there has been increased difficulty in obtaining visas for graduate study and that some have to do with governments using rankings of programs to determine acceptability of graduate study.

Following the tragedy of September 11<sup>th</sup>, there have been suggestions within the federal government that would prohibit training of foreign graduate students. Dean Atlas will stay on top of this potential repercussion.
