1. Approval of the Minutes from the June 27, 2006 meeting.

2. Report of the Curriculum Committee.

- Proposed Joint Degree Program in Law and Urban Planning (J.D./M.U.P.).

Professor David Simpson, the M.U.P. Program Director was present to present the proposal and answer questions. The joint program reduces the aggregate credit hour requirements by 21 hours by allowing urban planning courses to be used to satisfy Brandeis School of Law electives and vice versa. In addition, students in the joint program will be required to take a cross-listed course between law and urban planning. Students will have to be admitted to both degree programs to be considered for the joint program.

- Proposed Curriculum Changes in the Ph.D. in Social Work. Professor Ruth Huber, a Member of Council and Program Director for the Social Work Doctorate, presented the changes and responded to queries from Council. The changes are designed to consolidate and re-sequence the research and statistics courses in the curriculum. The proposed changes also add new courses in Advanced Qualitative Research and Advanced Measurement. The total number of required credit hours is increased from 50 to 56 .

- Proposed Reinstatement of the Ph.D. in Interdisciplinary Studies. Associate Dean Stremel presented the Reinstatement of the Interdisciplinary Ph.D. During the Provost's Program Review this year, the Committee recommended the expansion of the Interdisciplinary Master's degree to permit more students to pursue Interdisciplinary Studies and to broaden the scope of the degree to include cutting-edge opportunities. At the same time the Graduate School was asked to develop an Interdisciplinary Ph.D. This required only the reinstatement of a program that was suspended by UofL in 1979. The Graduate School and Provost's Office have gained CPE permission for the reinstatement. The degree takes two forms, one initiated by a student and the other developed by faculty to create a more permanent track within the Interdisciplinary Ph.D. program. Both approaches must engage at least three faculty members from two different departments or programs. The faculty must have the consent of their chair to participate in the degree program so that faculty work load agreements reflect the engagement and so that students are provided adequate supervision. Other issues such as financial support and Council's approval role were discussed. Council considered the proposal too complex for them to support without more study, so despite approval by the Curriculum Committee, Council voted to Table the proposal.
