My research interests center around implementation science and family relationships and include a number of topics in the areas of child welfare, relationship violence, trauma and high risk behaviors, health and mental health. In the area of child welfare, I have conducted a number of research studies on Solution-Based Casework practice and comorbidities of child maltreatment (e.g. domestic violence and substance abuse). I have also developed and tested a comprehensive model of training evaluation for child welfare that has served as a model for multiple federal and state grants and research initiatives. In the area of professional development in child welfare, I have also conducted research on supervision for federal outcomes, training reinforcement, specialization programs for public child welfare workers, virtual office configurations, and cultural competency. Similarly, I am conducting research on the use of psychoeducation as a strategy to prevent interpersonal violence and promote well-being among high-risk populations. In another branch of child welfare, I have conducted longitudinal, multi-method research on the quality of early childhood education and services, which included an assessment of the quality of child care services, as well as utilization of key health and community initiatives for children. A second major area of my research interests is health and mental health. I have been involved with funded projects related to trauma and related mental health issues, depression in primary care, cancer, schizophrenia, environmental health, and a global translational research initiative at the University level for which I was the evaluation lead. An overarching area of research across these substantive areas is implementation science, through which I have conducted a number of studies on facilitators and barriers to

implementation of evidence-based practices in a wide variety of settings including child welfare, education, health and mental health.
