PROFESSIONAL EXPERIENCE - GENERAL

During his professional career, Dr. Barber taught graduate and undergraduate courses in the areas of health and social policy, management, planning and social work practice. He participated in numerous curriculum development activities ranging from the baccalaureate through the doctoral levels, and coordinated one of the Kent School of Social Work's accreditation-self study. He also supervised continuing education programs and participated in the development and execution of federal, state and local interdisciplinary training programs and workshops for state licensure and certification personnel, human services workers and health professionals. Many of these activities required the use of distance learning technologies. In addition, Dr. Barber worked on many aspects of program planning, implementation and evaluation of health and social service delivery systems. For five years, Dr. Barber assumed responsibility for developing gerontology teaching, research and service activities for the total University.

Throughout his professional career, Dr. Barber made an extensive commitment to interdisciplinary, applied research. During the course of his research, Dr. Barber directed, designed, executed and reported on attitudinal surveys, needs assessment surveys, follow-up studies for diagnostic clinics, program evaluation studies, statistical reporting systems, institutional utilization surveys, panel surveys, as well as, health and social service manpower surveys. This work has required a wide variety of data collecting, processing, and reporting techniques and occurred in varied settings from large, complex organizational structures, such as state government or medical centers to small private organizations in the human services field and private industry.

Dr. Barber teaches courses in the areas of social policy, management and macro practice for the Kent School. He also is responsible for developing extramurally funded training, research and service projects for the same component. Dr. Barber coordinated the development work for the Ph.D. in Social Work and the Alternative Weekend Program, which was designed to make the social work program more accessible to people in the western part of the state. He also serves as faculty on the new Ph.D. program in Social Work and served in the early stages of the Program in Urban Affairs.

1987-1991 Associate Dean - College of Urban and Public Affairs, University of Louisville; and (1989-1994) Director, Urban Center on Aging (during 1988-89, Dr. Barber also served half-time as Acting Director, Kent School of Social Work)

The College of Urban and Public Affairs was composed of four components; three schools related to social work, justice administration and public affairs, and an applied research center. The College had approximately 47 full-time faculty, 40 full-time professional staff and 35 clerical staff. Every year approximately 550 students completed over 6,200 credit hours at the baccalaureate, masters and doctoral levels, and the College conducted close to two million dollars of sponsored research and training each year. As Associate Dean, Dr. Barber assisted the Dean in developing goals and plans, integrating and coordinating academic and budget activities and evaluating all schools and programs within the College. As Director of the Urban Center on Aging, Dr. Barber promoted gerontological interest throughout the University.

1979-1987 Associate Professor - Kent School of Social Work College of Urban and Public Affairs

In addition to his research work with the Urban Research Institute, Dr. Barber chaired the Comprehensive Health Specialization area at the Kent School of Social Work. The Kent School of Social Work, which was a component of the College of Urban and Public Affairs, had approximately 175 graduate, social work students and 16 full-time faculty. Dr. Barber was responsible for teaching health policy and planning, system management and community organization/development courses, as well as, advising students and field supervision. As chairperson of the Curriculum Committee, he supervised the school's self-study and accreditation process, participated in the proposal development process for both the Doctor of Science in Urban Studies and Baccalaureate Social Work Program. He also conducted numerous interdisciplinary service projects for community and state agencies with students and faculty.

1973-1979 Associate Director and Senior Researcher - Human Services Development Institute, Center for Research and Advanced Study, University of Southern Maine

The Human Services Development Institute conducted applied research and delivered direct services to help human service agencies manage the process of change. It concentrated its efforts in three functional areas: management systems, policy research and training. As Associate Director, Dr. Barber was responsible for project development related to management systems. He also shared responsibility for the development of management and personnel policies and procedures governing the Institute's operations. Between 1973 and 1979 the Institute grew from three professional employees to thirty-one with an annual budget of over one million dollars. During this period, Dr. Barber directed and supervised more than a dozen

projects--totaling approximately \$1,300,000--related to health, mental health, management information systems, telecommunications, manpower utilization and program evaluation.

1967-1969 Health Services Officer - U.S. Public Health Service, Community Health Service, Division of Health Resources

When Dr. Barber was with Community Health Services, it had direct responsibility for establishing health standards, group practice, comprehensive health planning and Appalachia and migrant health programs. It also provided consultation regarding professional practices and standards to the Bureau of Health Insurance, S.S.A. (Medicare), Department of Social and Rehabilitative Services (Medicaid), Department of Housing and Urban Development (Model Cities), and the Office of Economic Opportunity (Neighborhood Health Centers).

During his two years with the Public Health Service, Dr. Barber worked on the development and execution of education and training programs for professionals and paraprofessionals. In addition, he was responsible for reviewing short term training proposals and the development of training materials for state surveyors of hospitals, nursing homes and home health agencies. The latter work resulted in a national training center at the University of Tulane to train state health personnel in survey and consultation techniques.

1966-1967 Director of Research - Kennedy Center, Bridgeport, Connecticut

The Kennedy Center maintained a wide variety of services, which ranged from a diagnostic clinic to a sheltered workshop for the mentally retarded. Dr. Barber participated in most all phases of program planning, administration and evaluation. He also directed several community education and staff training programs in addition to developing and supervising two specific research activities. The first involved a follow-up study of 1,200 clients seen by the Kennedy Center's Diagnostic Clinic. The second study analyzed employers' attitudes towards hiring and training mentally retarded people for competitive employment. Specific program recommendations resulted from both studies.
