







# Conference Theme: "Latinidad y Rompiendo Barreras"

The 2017 Conference theme, "Latinidad y Rompiendo Barreras," focuses on the question: What does it mean to be a Latino/a lawyer in our communities? In the United States, Latinos make up roughly 18% of the population. Yet, according to the ABA Lawyer Demographics for 2016, only 4% of the 1,315,561 licensed attorneys identify as Latino/a. We intend our conversations to focus, in part, on how to break barriers that face Latina/o law students and lawyers within our communities, personally and professionally. In an increasingly globalized world, NLLSA recognizes that the need for diverse attorneys in the legal field is greater than ever. As Latina/o law students, our unique experiences, diverse cultural backgrounds, and linguistic abilities can provide value to legal organizations, their clients, and throughout the legal profession itself. This year, our national organization will attempt to harness this collective value through a collaborative and educational approach at the National Conference

## KEYNOTE SPEAKER:

### ALEX PONCE de LEON



Alex Ponce de Leon is corporate litigation counsel for Google Inc. focusing on discovery issues. At Google he develops and implements innovative and efficient discovery strategies for a wide variety of litigation matters, including, complex litigation, arbitration, patent cases, and internal investigations. He also directs counter-discovery strategies using computer forensics and digital investigations techniques. Alex successfully defends against "discovery-on-discovery" in motion practice. Besides managing his own discovery caseload, he also implements new discovery policies and procedures designed to reduce costs and mitigate legal risk across the company.

Alex was named a "Top 10 30-Something" by the Association of Corporate Counsel in 2015. He was recognized as a 2016 Diversity Leader by the Hispanic National Bar Foundation. Alex is a member of Sedona Conference Working Group 6 on International Electronic Information Management, Discovery and Disclosure.

Prior to joining Google, Alex was a senior litigation counsel at the Intel Corporation where he primarily focused on discovery and general litigation matters. Alex began his legal career as an associate at Pillsbury Winthrop Shaw Pittman where he worked on large and complex litigation cases. Before practicing law, Alex was a policy advisor for the California State Legislature and a management consultant for Accenture. He received his BA from Brown University, his MSc from the London School of Economics, and his JD from Northwestern University School of Law.

#### **TRANSPORTATION**

- The Metropolitan Atlanta Rapid Transit, or MARTA, is an affordable way to travel. MARTA offers both bus train service. Standard MARTA fare is \$2.50 for a one-way trip.
- Multi-ride passes are available if you plan on riding MARTA multiple times in one day.
- Fare may be purchased at a MARTA RideStore or via a Breeze Vending Machine. Breeze vending machines are located all across MARTA stations. Breeze Cards are reloadable and reusable. Each Breeze Card costs an additional \$2.00.


- MARTA to Georgia State University College of Law
  - On the North and South line, travel to the Peachtree Train Station on the North/South rapid rail line. Look for the Ellis Street exit in the station. Go up those escalators then take the Peachtree Street West exit out of the station. Turn right. The college is less than a block from the station at the corner of John Wesley Dobbs Avenue and Park Place, next door to the Georgia-Pacific Center.
- MARTA to Atlanta's John Marshall Law School
  - o Take MARTA to the Arts Center Station exit onto W. Peachtree St. and turn right walk three blocks and cross the street at 18th St.
- Driving Directions to Emory University School of Law from the Airport
  - Take I-85 North to Clairmont Road, turn right. Travel to North Decatur Road, turn right. Travel to Clifton Road, turn right. Make the first right onto Gambrell Drive. Gambrell Hall will be on the right. Proceed to Lowergate parking.






