Meredith: Professor Abrams is also hosting a "Just Dance" fundraising competition with herself and a few other professors.

SGA Senator: Kalynn Walls

- SGA in discussions with UL Tuition and Fees on:
- About a 1% increase in tuition for students in order to give faculty a raise across the board.
- UL parking is grossly under budget and they are discussing raising parking passes on purple lot and residential parking passes.
- SGA is working on a better night time ride system for students, possibly creating an app for UL Campus Police to assist. New UL Police Chief is really invested in making something work, the golf cart system was a failure.
- Newly elected SGA Top 4:
- President-elect Jasper Noble
- Executive Vice President-elect Kayla Payne
- Services Vice President-elect Lydia Burns
- Academic Vice President-elect Sabrina Collins
- As of last week, UL parking tickets will now double after 14 days rather than after 7 days.
- The Bar Prep fee proposal with Barbri was withdrawn. The law school will have the opportunity to propose it again next year. Questions about that proposal to the Tuition and Fees Committee can be sent to me or Cash Collins, as the Professional Schools Student Representative on the Tuition and Fees Committee. SBA may consider a town hall meeting in the Fall to get student input ahead of another proposal.

LBA/KBA Rep: Paige Ezell

- Connor introduced me to the members of the LBA as the new student representative for Brandeis
- If anyone has any questions about what is going on with the LBA, let Paige know.
- There is ongoing discussion regarding the best way to attract young attorneys to LBA, any ideas are welcome
- LBA membership fees for students are around \$15. Not many young attorneys, compared to firm partners, are LBA members. LBA is currently trying to find new ways to attract
- The LBA is wanting to renovate their space and create new ways to generate money
- Connor: Only 20% of attorneys in Louisville are currently LBA members.

3L Reps: Anthony Johnson & Lauren North

- We should announce somewhere that we are the 3L reps.
- Kerby: I am willing to post about each of the 3L reps on social media.
- Paige: A "Meet Me Monday" on social media could be a good idea.

2L Reps: Michael Mann & Peyton Griffee

- Peyton: Student mentioned an ice machine could be something a lot of students would like.
- I looked the machines up. They are \$2,000.
- Peyton: A lot of people have been telling me that they would like premade coffee instead of Keurig machines.
- Lauren: K-cups are wasteful. Can we replace them with reusable K-cups?
- Dru Childress: I talked with Dean DiSanza last year about a Starbucks vending machine, and she was supposed to check on possible contract issues with our other vending machines. That's something we could check on.

Connor Cafferty:

- How do we feel about mandatory 1L torts class online?
- General consensus is strong opposition.

Paige Ezell:

- Main concern with 1Ls taking online course is that most students are used to taking undergrad online courses that required minimal effort. This could falsely lead students to think they can get by law school with the same effort that was required of them in undergrad.
- If this school is concerned about bar passage, implementing a mandatory online torts class seems counterintuitive.

Michael Mann:

- Also disapproves.

Lauren North:

- Professor Abrams is a very talented instructor. In her hands, there is a likelihood that online Torts will turn out okay.
- Biggest feedback that I am getting, which should be most compelling to administration is, "had I known that I would be forced to take an online class, I would not have chosen UofL."
- Requiring students to take online class without their consent that they have to take an online Torts class may alter how many students choose this school.

Connor Cafferty:

- At Orientation, students are told that they have to change their methodology to keep up with law school curriculum. Implementing a mandatory online class is not consistent.

Imani Powell:

- Video lectures are very different than assigning reading and discussing it in class. Are there office hours?

Connor: I think there will be online office hours.

Madeline Reed: I doubt as many students will keep up with the reading if they know that they will not be cold-called.

Lauren North:

- I told Professor McNeal that I was comfortable with advocating for more flexibility I would not have assisted if I knew it would lead to this result.
- Our school advertises that it implements the Socratic method.
- Law school's faculty is decreasing. This will be less of a problem with the upcoming class being 90 people.
- This online class may be a way of keeping talented staff to let them do more with their free time. Perhaps, they need to hire more staff members.

Connor:

- This will be the highest enrollment our university has in nearly a decade. So, if you think about the amount of seats filled in upper-level classes, online courses could solve the potential issue of upper-division courses being overfilled.
- This semester, the 2Ls will likely have to take all core-courses because electives and upper-level courses are being quickly filled.
- Motion to take a stance against mandatory Torts online for 1Ls
- Motion passed unanimously
- SBA does not agree with administration's decision to require all secondsemester 1Ls to take Torts 2 online, after hearing student feedback among 1Ls and 2Ls. This opinion gained unanimous approval in SBA.
