Each Fellowship is part of the Consumer Protection Outreach Initiative of the ABA Antitrust Law Section. Students will be placed in the Consumer Protection Departments of each state/territory/agency office <u>and at least 50% of each student's time may be devoted</u> to consumer protection matters. The remainder of each student's time, at the option of each site, may be devoted to antitrust matters.

To be eligible for a Janet D. Steiger Fellowship, applicants must currently be a first or second-year law student at an ABA accredited law school. Each Steiger Fellow will receive a gross stipend of \$6,000 for a specified 8- or 10-week period and <u>will be responsible</u> <u>for all taxes and other required deductions</u>. Please note that the Steiger Project in its discretion offers an optional small supplemental housing/travel allowance where a clear need is demonstrated.

Applications and all accompanying material **MUST** be **received** by **November 20, 2021.** Application should be transmitted via email to <u>ABASteigerFellowship@americanbar.org</u>. Applications that are incomplete or received after **November 20, 2021**, <u>will not be</u> <u>considered</u>. There is no application fee.
