In addition when talking about sexual practices, I will make an effort to use more inclusive terms to minimize assumptions and make patients feel more comfortable talking to me if they are of the LGBTQ population.

One specific skill I will implement in future practice is being inclusive while avoiding making assumptions. This will make the patient feel respected, heard, and comfortable when coming to see me.

Look, I understand this is an important topic for physicians to know, because I understand the LGBTQ community is oftentimes discriminated against/not accurately represented, esp. in the medical community. But there are a couple things that I disagreed with in this module: 1. The module asserted that a physician cannot tell a patient that they are not knowledgeable enough about hormone treatment to help them, because physicians are supposed to be life-long learners. You can't force a physician to perform treatment they are genuinely uncomfortable with. Just like an OBGYN is allowed to refuse to perform an abortion as long as they refer the patient to someone else, primary care physicians should be allowed to refuse prescribing hormone therapy as long as they're able to refer the patient to someone else. As a pediatrician, I already know I'm not going to feel comfortable prescribing puberty suppression (because the concept of halting a major physiological process genuinely worries me, even if it is "reversible", because I don't think there is enough research out there that there aren't long-term repercussions). However, I WILL refer to someone who is more comfortable doing so, like an endocrinologist. This doesn't make me a bad physician. 2. The "they" pronoun may make the patient more comfortable, but it may be grammatically confusing in the medical record, considering this is a pronoun used to refer to a plural group of people. You can't enforced that we use this pronoun and then say nothing when there is genuine GRAMMATICAL confusion within the medical record. 3. The "gendered language" in regards to body parts  $\rightarrow$  these are MEDICAL terms, do not tell me that MEDICAL terms are now offensive to people. I'm going to keep using these terms because they're MEDICAL, and if someone tells me they're offended, I'll explain why I use these terms. Everything else was fine.
