Drive down the parkway and turn left on 48th Street. Go to 5th Avenue and turn right. Drive to 47th Street and turn right. Hotel is located on the left side of 47th Street & 7th Avenue. If you are choosing to valet park your vehicle, please pull-up directly in front of the hotel on 7th Avenue.

From I-95: New Jersey Turnpike North to Exit 16E-Lincoln Tunnel. After exiting the tunnel bear with the road to the left. Make a left on 42nd Street. Make a right on 10th Avenue. Drive to 48th Street and turn right. Drive to 5th Avenue and turn right. Drive to 47th Street and turn right. Hotel is located on the left side of 47th Street & 7th Avenue. IRA JACOBSON, MD

Dr. Ira Jacobson earned his BS summa cum laude from Yale University and his MD from Columbia University College of Physicians and Surgeons. After completing an internship and residency at the University of California San Francisco he trained as a fellow in gastroenterology and Hepatology at Massachusetts General Hospital and Harvard Medical School.

In 1984, he joined the faculty at Weill Cornell Medical College and New York Presbyterian Hospital. During his 30 years at Weill Cornell, Dr. Jacobson served as Chief of the Division of the Gastroenterology and Hepatology from 1998-2015 and was Vincent Astor Distinguished Professor of Medicine as well as Medical Director of the Center for the Study of Hepatitis C. In March 2015 he assumed the position of Chair of Medicine at Mount Sinai Beth Israel Medical Center, and Vice Chair of Medicine and co-Director of the Liver Institute at the Icahn School of Medicine at Mount Sinai.
