Target Audience

Statement of Need/Program Overview

It is estimated that approximately 50% of people living with HIV/AIDS (PLWHA) experience significant problems with mental health. Major depression is nearly 5 times greater in PLWHA, while generalized anxiety disorder is nearly 8 times higher, and panic attacks is more than 4 times higher than the general population. Furthermore, PLWHA experience a high rate of trauma and are more likely to develop post-traumatic stress disorder (PTSD).

Unfortunately, mental illness is frequently untreated or under treated leading to decreased adherence to medical appointments and HIV medications, increased HIV risk behaviors, and faster progression to AIDS, increased disability, and increased morbidity and mortality. This program will allow clinicians to address some of these mental health challenges in order to break this cycle.

Educational Objectives

After completing this activity, the participant should be better able to:

- Recognize the changing Mental Health challenges facing HIV-infected patients.
- Utilize new approaches for the long-term psychiatric management of HIV-infected patients.
- Implement strategies for treating depression, PTSD and dual diagnosed patients.
- Discuss issues related to Aging and Behavioral Disorders in HIV care.
- Provide accurate and appropriate counsel as part of the treatment team.
