Human Trafficking: In Plain Sight

Statement of educational need

Human trafficking occurs in every state, city and community. From 2007 to 2018, the National Human Trafficking Hotline received over 2,000 calls and reported 490 human trafficking cases in Kentucky. Because victims of trafficking may seek medical attention for the medical and psychological consequences of assault and neglected health conditions, health care professionals are in a unique position to identify victims and provide assistance. Estimates show that approximately 80% of human trafficking victims are women, and health care providers often are the first professionals to have contact with trafficked women and girls. One study found that close to 50% of trafficked individuals saw a health care professional during their exploitation.

Clinicians need to be aware of red flags that their patient could be a victim of human trafficking, best practices for screening and assessing patients for trafficking, how to respond as a health care professional, and resources for assisting the victims.
