**Acknowledgement of Post 9/11 GI Bill Benefits**

**Tuition** The VA pays in state resident tuition rate for undergraduate, graduate, and professional programs.

**Notes**

1. We do not submit tuition and fees to the VA until **AFTER the 100% drop date for each semester.**
2. Students have **the first full week of the fall/spring semester to add/drop courses.** For the **winter** session and **summer** terms, tuition is submitted on a term-by-term basis after the last day to drop.
3. Keep this in mind when you receive a letter that states we did not submit tuition and fees when the VA processes your enrollment.
4. This letter explains that we submit your enrollment so that your remaining benefits are not delayed.
5. The Post 9/11 GI Bill **covers;** lab fees, technology fees, student recreation fee, course fees and fees exclusive to student degree plans and/or programs.
6. Fees **NOT** covered by the Post 9/11 GI Bill **include: housing, meal plans and the Primary Health Care Fee.**

**Basic Allowance for Housing (BAH)** BAH is calculated for the University of Louisville's Belknap campus zip code (40292) and is currently **\$1,557** per month (subject to change). Those **enrolled solely in distance education courses** will be entitled to ½ the national average BAH, **\$901** per month. The housing allowance is **paid one month behind, on the 1<sup>st</sup> of each month.**

**Notes**

1. Do not expect to use BAH to pay the on-campus housing and meal plan balance **before the tuition deadlines for the fall and spring semesters**
2. Please see page 5 of the reference guide for disbursement information. The housing and meal plan payments are due prior to the start of the semester.

**Book Stipend** The book stipend is \$41.67 per credit hour to a maximum of twenty-four credit hours per calendar year, up to a maximum of \$1,000. The book allowance is **sent out two weeks** prior to the start of each semester.

**Enrollment Verification** On the last day of each month, you must verify your enrollment with the VA. If you do not verify receipt of the VA's text or email, the VA will not pay BAH.

***I have read the Post 9/11 G I Bill reference guide, and I understand:***

- It is my responsibility to ensure I have completed the Veterans Education Benefit Summary in ULink each semester to request use of my benefits.
- If I do not complete this form before the tuition due date, I could be subject to a financial hold and/or late fee and my benefits will be delayed.
- How and when my tuition will be processed to the VA for receipt to the university
- Housing allowance and book stipend will be direct deposited into bank account provided at the time of the application for benefits.
- All benefits are paid at the percent indicated on the Certificate of Eligibility. If my percent is less than 100%, my portion of the tuition is due by the tuition due date.
- If my benefits run out in the middle of the semester, I am responsible for the tuition not covered by the VA.
