

Graduate/Professional Students Post-Graduation Education and Employment

2022-23 Executive Summary


The University of Louisville and Institutional Effectiveness (IE) collect information related to students' continuing education and employment plans after graduation through the following sources:

- Degree Application collected at the time the student applies for graduation
- Graduating Student Survey administered between the time the student applies for graduation and the commencement ceremony
- First Destination Survey administered to the student three months following commencement and open for six months

In combination, these surveys provide useful information regarding students' initial post-graduate plans, their more solidified intentions at the time of graduation, and their actual experiences post-graduation. This report summarizes these self-reported student responses. Responses presented here represent the most recent information collected for each student.

Post-Graduation Plans

For the 2022-23 academic year, 2,312 students earned a Master's or Doctoral degree. Of those students, 2,031 provided information about their primary post-graduation plans.




- 57.83% (1,337) indicated they were employed full time (on average 30 hours or more per week)
- 3.24% (75) indicated they were employed part time (on average less than 30 hours per week)
- 9.39% (217) indicated they were enrolled in a program of continuing education
- 0.30% (7) indicated they were not seeking employment or continuing education at that time

- 0.04% (1) indicated they were participating in a volunteer or service program (e.g. Peace Corps)
- 3.07% (71) indicated they were planning to continue education but were not yet enrolled
- 10.29% (238) indicated they were seeking employment
- 3.68% (85) indicated they were serving in the U.S. military
- 12.15% (281) provided no information regarding their post-graduation plans

Salary

For the 2022-23 academic year, 1,322 students graduating with a Master's or Doctoral degree provided information on their pre-tax salary.

- 0.99% (23) indicated making less than \$10,000
- 1.56% (36) indicated making \$10,000-\$19,999
- 1.99% (46) indicated making \$20,000-\$29,999
- 4.070/ (10) indicated material \$20,000 \$20,000
- 4.07% (94) indicated making \$30,000-\$39,999
- 6.31% (146) indicated making \$40,000-\$49,999
- 8.82% (204) indicated making \$50,000-\$59,999
- 7.79% (180) indicated making \$60,000-\$69,999
- 5.84% (135) indicated making \$70,000-\$79,999
- 4.97% (115) indicated making \$80,000-\$89,999
- 2.72% (63) indicated making \$90,000-\$99,999
- 7.92% (183) indicated making \$100,000-\$149,999
- 3.46% (80) indicated making \$150,000 or more
- 42.82% (990) provided no information regarding their salary
