The purpose of PEACC is to provide advocacy and assistance to university students, staff and faculty who are affected by sexual misconduct, sexual violence, intimate partner violence and stalking. An advocate will listen to you and review your options. These options include: crisis intervention, housing accommodations, medical care (including an exam), academic assistance, counseling, police notification, and Dean of Student's notification (for conduct procedure options). This interview is confidential and your name will not be released without your written permission.

The Counseling Center provides comprehensive counseling and mental health services to students. A licensed counselor will listen to you and provide you with ongoing counseling services. Counseling sessions are confidential and your name will not be released without your written permission.

University Hospital Emergency Room 502-562-3000

You may be given medical care by a trained Sexual Assault Nurse Examiner (SANE). The exam is free of charge and will not be billed to your insurance. You may choose to make a police report as part of your SANE exam. If you are 18, your parents will not be notified without your consent. Making a report and completing an exam preserves the option to prosecute, but does not commit you to pressing charges.

Campus Health Services 502-852-3172

Campus Health Services (CHS) provides a variety of confidential primary care medical services including pap smears and sexually transmitted disease testing as well as psychiatric services. Routine well and sick visits are covered on your campus health fee or private insurance. Diagnostics testing is available at cost for those without coverage or preferring anonymity. Although CHS does not have the capability to provide forensic sexual assault exams on site, CHS can assist the student with accessing the appropriate services and provide continuing care following your initial examination.

Psychiatric Services 502-852-3179

CHS provides confidential psychiatric services at no-charge to any student enrolled at UofL. Licensed, board-certified faculty psychiatrists and psychiatric nurse practitioners provide complete initial psychiatric evaluations; medication maintenance, psychotherapy, referral to other community or campus resources and referrals for hospitalization, if needed. Students are seen by appointment only and must be referred by a CHS primary care provider, a Counseling Center counselor, outside psychiatrist or the Director of the PEACC Center.

HSC Counselor 502-852-0996

CHS provides confidential counseling services on the HSC campus at no-charge to any student enrolled at the Health Sciences Center. A licensed counselor provides complete initial evaluations and ongoing therapy for a variety of conditions such as anxiety or depression. The HSC counselor works closely with the CHS service physicians and psychiatrists should medication be recommended by the counselor for the management of any conditions. HSC students may self-refer or be referred by a faculty or staff member, fellow student or health service provider.

REPORTING OPTIONS

You may report sexual violence, sexual assault, sexual harassment or stalking to the following University department or representative. You may also report to any University employee responsible for providing direct services to students, where the employee role and the nature of the

services provided would lead a student to reasonably believe that the employee has the authority or responsibility to take action, or redress the harassment.

University Police 502-852-6111

An officer will contact a PEACC Program advocate who can be present during the interview process. You will be interviewed by an officer who will make a report. Making a police report does not obligate you to prosecute but it does make a record of the incident. The report will include your name, the alleged perpetrators name, and details of the incident. This report will be distributed within the police department and to department superiors. Although it is not typical, the information in this report may be requested by outside sources under public information laws. An officer may secure the scene for evidence collection and conduct an investigation. An officer will offer to transport you to University Hospital for a medical exam.

An officer will review options for prosecution and may accompany you to file charges. If you pursue a criminal case, a police officer and an advocate will accompany you through the court process. You will not need to hire an attorney, you will be assigned a prosecutor who will review your case and assign charges. The prosecutor will explain the court process and will address questions regarding the charges.

Dean of Students Office 502-852-5787

The Dean of Students Office will explain the student conduct process. If an investigation is required, witnesses will be contacted and will be asked to present information at a campus hearing. Various sanctions can be served depending on the situation. One sanction is a *No Contact Order* – A directive to cease and desist from any intentional contact, direct or indirect, with one or more designated person(s). A *Persona Non Grata* is a letter that informs the accused that she/he is forbidden from entering some or all university residence halls or the surrounding exterior areas for any reason during a specified timeframe.
