# RECOMMENDATION TO THE EXECUTIVE COMMITTEE OF THE UofL ATHLETIC ASSOCIATION BOARD OF DIRECTORS REGARDING THE EMPLOYMENT OF THE MEN'S GOLF HEAD COACH

Executive Committee - May 13, 2020

#### RECOMMENDATION:

The Chair of the Board recommends that the Executive Committee authorize the Athletic Director to execute an employment contract with Ryan Blagg as Head Coach of Men's Golf, effective June 1, 2020, and consistent with a term sheet as <u>presented</u>.

#### BACKGROUND:

Ryan Blagg; Assistant Coach, Men's Golf at Baylor University. Appointment as Head Coach of Men's Golf, at University of Louisville, effective June 1, 2020, subject to approval by the ULAA Executive Committee.

Education: B.A. in Communications, University of Arkansas, 2002

Other Relevant Experience:

2012 - Present: Assistant Men's Golf Coach, Baylor University

2010 - 2012: Assistant Men's and Women's Golf Coach, Houston Baptist University

Coach Ryan Blagg served for eight seasons as Assistant Coach with the Baylor men's golf program and completed his 10th season as a Division I coach in 2019-20. During Blagg's tenure, the Baylor Bears have advanced to NCAA Regional play in all seven of Blagg's seasons, including a school-record streak of four consecutive NCAA Championship berths. His accolades include being named the 2017 Jan Strickland Award winner (given to the nation's top assistant coach) and serving as an assistant coach on the United States' 2018 Palmer Cup team.

Prior to his joining the Baylor University program under legendary head coach Mike McGraw, Blagg spent two seasons at Houston Baptist, where he helped the women's program capture its second- and third-straight Great West Conference championships. In 2011, he guided the Great West Conference individual medalist, player of the year and four other all-conference selections.

Prior to Houston Baptist, Blagg served as the Head Rules Official and then the Tournament Director for The Gateway Tour. He played professionally for six years on the national circuit, recording multiple top-five finishes.

He played collegiately at Arkansas, where he graduated in 2002 with a bachelor's degree in communications. He was named to the SEC Honor Roll each of his three seasons in Fayetteville. He began his collegiate career at Tyler Junior College, where he played for former Baylor head coach Greg Priest and led the team to the 1998 NJCAA National Championship, earning All-American and Academic All-American honors.
