Mr. Durbin briefed the committee on the university's financial activity through October 31, 2022, noting that overall revenues continue to exceed expenses, the net margin is approximately \$25 million less than the prior year, and tuition revenues were \$5 million below budget primarily due to lower than anticipated graduate level enrollments.

Using the **attached** presentation, Mr. Durbin also shared an actual-to-budget report, updates regarding dollar amounts of liquid cash, and days of cash on hand.

Mr. Durbin then fielded questions from the committee.

Ms. Zimmerman departed the meeting at 2:18 p.m.

The chair thanked the CFO for his report.

III. Executive Session

Dr. Burse made a motion, which Mr. Brinkman seconded, to recess to executive session to discuss a specific business proposal pursuant to KRS 61.810(1)(g).

The motion passed and the open meeting recessed at 2:22 p.m.

The open meeting reconvened at 3:00 p.m. Chair Medley reported that the committee discussed a specific business proposal.

Highlights of FYTD October 31 Financial Activity

FYTD Activity through October 2022:

Overall revenues continue to exceed expenses (positive margin)

- General Fund and ULAA maintain FYTD positive margins despite \$5 mill tuition shortfall (from budget)
- Research Foundation FYTD margin is slightly negative due to IGT match payment timing of \$10 mill
- Cash and liquidity levels continue to improve
- Use of Foundation funds is increasing

FYTD Activity Compared to Prior Year:

Net Margin is approximately \$25 mill less than prior

- General fund still performing well
- ULAA approximately \$6 mill less primarily due to men's basketball ticket payment due date and one less home football game
- Research Foundation approximately \$30 mill less due to \$10 mill IGT match payment timing, recognition of \$6 mill CARES revenues in prior year, lower grant activity and spending from prior period ULH margin share
- Cash and liquidity levels improved

Other Considerations:

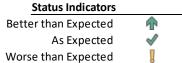
Tuition revenues running \$5 mill below budget primarily due to lower than anticipated graduate level enrollments

- Mitigation plans to counter shortfalls:
 - Met with every dean to confirm plans to balance budgets (align expenses with revised revenues)
 - Focusing on Spring retention to improve revenues
 - Deploying, if necessary, the 1% contingency

Still trending toward approved balanced budget

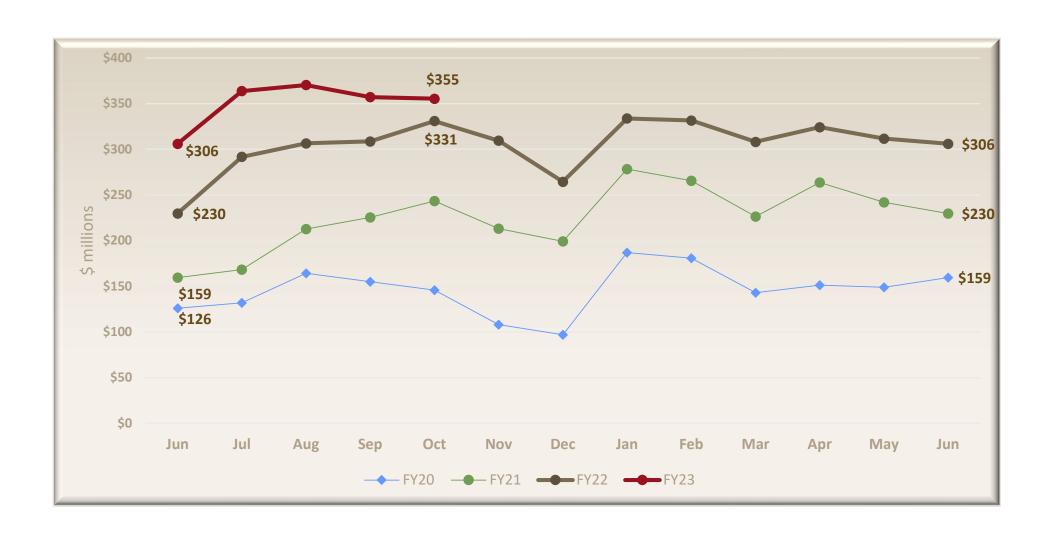

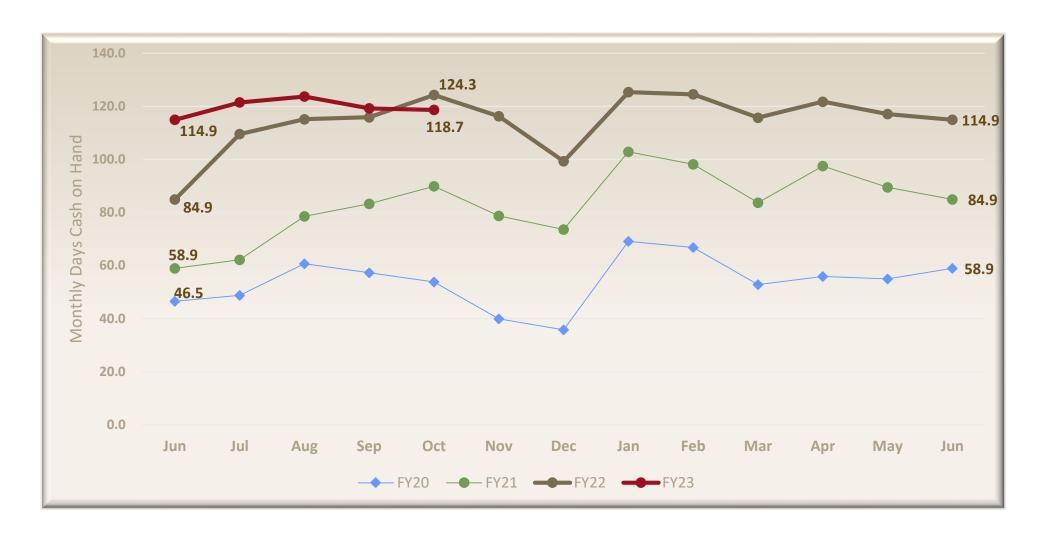
Liquid Cash – FY 2020 to FY 2023
