Clarifying Statement

The University acknowledges the unique nature of this project delivery method and understands it may not align with every firm's expertise. Therefore, we are committed to a comprehensive proposal evaluation to select the ideal partner. We are looking for firms with a track record of successful projects employing this approach, a strong collaborative relationship with their design team, a demonstrated ability to provide accurate and robust estimates, innovative design solutions, and reliable project management.

Given the diverse approaches, assumptions, and exclusions inherent in each proposal, variations are expected.

Clarifications

- 1. Roof replacement is included in the scope of work.
- 2. The University will by purchasing and installing the audio video equipment.
- 3. The general contractor is required to be the prime contractor for this project and would also be the firm responsible for submission of the proposal.

Revisions

1. RFP Section 3 – Evaluation Criteria Process

The University has revised the evaluation process, removing the lump-sum financial proposal from scoring criteria. Final selection will be based solely on interview and presentation performance. The highest-scoring short-listed proposer shall provide a detailed and well-supported financial offer (complete project scope, including design and administrative costs), based on the information and renderings provided, to ensure alignment with the University's extensively researched internal project estimate. These offers are to include proposer-determined contingency amounts. The University reserves the right to negotiate the final offer. If negotiations are unsuccessful, the University will proceed with the next highest-scoring proposer.
