The following shall clarify and/or modify the original bid document(s) as issued by the University of Louisville.

- 1. Is there an opportunity to walk the areas with University personnel? All the compactors are located in public access areas and University personnel need not be present for vendor walk throughs. Any vendor wishing to be accompanied by University personnel must request an appointment and we'll try to accommodate based on our availability. For appointments contact Greg Schetler at Gregory.schetler@louisville.edu.
- 2. The only fillable field for the bid is disposal. Is the request to include hauling and disposal as one line item, or will the pricing sheet be changed to add both hauling and disposal fields? Our preference is for hauling, disposal and rental to be included as one line item and the price sheet will not be changed. Bidders may add fields as necessary to break down price components as long as the total price is also shown.
- 3. Is there any historical hauling and tonnage that can be provided? Tonnage estimates have been provided based on recent activity see attachment D. The actual totals will vary from month to month and are not guaranteed.
- 4. Are all compactors owned by the University? No, bidders are expected to provide their own equipment.
- 5. The RFP states that equipment will be fully maintained by the contractor. Does this include all maintenance and repairs to compacting units? Yes
- 6. Are there established times for when compacting units can be serviced? No. Vendor will need to coordinate with Physical Plant operations regarding maintenance schedules.
- 7. Can you provide the average hauls per month by compactor by site (excluding the Dental School)? No. The pickup frequencies are stated on the price sheet for each compactor, however, the average hauls per month may vary.
- 8. Can you provide the average tons per haul for each compactor by site? No. Only estimated tons per month per compactor will be provided see attachment D. Actual totals will vary from month to month and are not guaranteed.
- 9. Can the proposal price be quoted as haul plus disposal plus rental? See question 2.
- 10. Are any of these units still part of the Green City Partnership? No.

Bidder must acknowledge receipt of this and any addenda either with bid or by separate letter.
