#### **CALL TO ORDER**

Chair Smith called the meeting to order at 2:30 p.m.

#### **ACTION ITEM: APPROVAL OF THE MINUTES - SMITH**

The minutes of the November 11th meeting were unanimously approved.

## **REPORT: BUDGET UPDATE - DURBIN**

Mr. Dan Durbin, UofL's Chief Financial Officer, updated the Senate on the University's past, present and future budget. Some of the highlights for fiscal year 2019 included: a total revenue increase by 5%, to \$1.1B; a total expense increase by 3%; an increase in our value to \$23M; and, the financial position remains strong with total assets at \$1.3B. Cash on hand was an issue for SACS and the financial rating agencies, but we continue to make progress and increase our cash situation. All revenue increased, including HSC's. Mr. Durbin said that a corner has

been turned and we are no longer in a gloom and doom situation. In November, Moody's (a financial ratings agency) lowered our rating. This was due mostly to the acquisition of KentuckyOne, though Moody's is known to be negative on higher education and non-profit healthcare. Standard & Poor's, another financial rating agency, did not lower our rating after the acquisition. The takeaway for fiscal year 2019 is threefold – we improved our financial position and performance, we have a clean audit opinion and we are actively investing in student, staff and programs. Mr. Durbin said many people worked very hard on these efforts and we should all be very proud. He also noted that without the 5% cut, this report would not look so great. Turning to the present, fiscal year 2020, revenue is already up 2% over last year. An unforeseen challenge, was a drop in fall's tuition by \$1.6M from fall 2019. We are taking steps to compensate for this in the spring semester. This issue is controllable by enrollment, but it is a very competitive field. To include more people in the future budgeting process, a new Budget Planning & Monitoring Committee will be developed to advise President Bendapudi and her team. It will advise how allotted funds align with the Strategic Plan's vision. It will be co-chaired by Provost Boehm (academics) and Mr. Durbin (financials) and have about 30 members from deans, the senates, SGA and administrators. There will be three subcommittees - the Funding Request Sub-Committee, the Budget Model sub-committee and the Administrative Unit Budget review Sub-Committee.

#### Questions

- Question: We have been told that our budget is final. Is that true?
  - o Reply: Yes, unless something happens with enrollment.
- Question: How will the University manage the 2% raise and the deferred maintenance issues?
  - Reply: Last year, we presented a 3-year plan to the Board of Trustees for the raises and will make sure they can continue. As for deferred maintenance, the state is requesting funding for it from the legislature, but it a matching-fund request. We are studying our most pressing issues and how to get the matching funds.
- Question: Was the purchase of KentuckyOne a good one for us?
  - o Reply: Absolutely. Financially, academically and in every way.
- Question: What about the \$590M loan?
  - Reply: We are meeting with every legislator one-on-one. The pushback has been on the loan's forgiveness.
- Question: Grants and contracts how do you project those in the future?
  - Reply: It depends on trends. What you see is the cost of the grants. This is another area that SACS, Moody's and S&P look at. Three years ago, we were an institution on the decline. Now, we are very different and grants are up.
- Question: Is HSC losing money in clinical or research?
  - o Reply: Clinical.

Mr. Durbin thanked all who helped make 2019 a good year. The full presentation is online.
